Historical Note:

The attorney general is the chief law enforcement officer of the Commonwealth, advising and representing it in all matters in which it is a party or has an interest, and representing the public in affirmative litigation to protect public interests. The post was designated as a gubernatorial appointment per Const Pt 2, C 2, S 1, Art 9; then as an elective office per Const Amend Art 17 (ratified 1855). St 1919, c 350, s 33 provided for a Dept. of the Attorney General (MGLA c 12). In its annual reports the unit has been called variously: Attorney General's Dept., Attorney General's Office, and Office of the Attorney General. Its functions are currently described in MGLA c 12.

Historical Note:

Per Massachusetts St 1899, c 259, every charitable organization whose personal property was exempt from taxation by PS c 11, s 5 was to transmit to the State Board of Charity an annual report showing property, receipts, and expenditures. St 1901, c 405, St 1910, c 181, and St 1919, c 350, s 87/GL 1921, c 180, s 6 (for the board's successor, the Dept. of Public Welfare), provided for the issuance of a certificate of incorporation by the state secretary after an investigation by the board/department into the legality and suitability of purpose of the applicant organization. Per St 1954, c 529, s 1 (currently as in MGLA c 12, ss 8A-M), these responsibilities were passed to a newly established Division of Public Charities in the Attorney General's Office.

Historical Note:

The Victim and Witness Assistance Board, established by Massachusetts's Victim Bill of Rights (St 1983, c 694, effective 1984--see currently MGLA c258B), is chaired by the state attorney general. The board governs the Massachusetts Office of Victim Assistance

(MOVA), created in 1984 as the executive office of the board (Minutes, Aug. 28 and Oct. 24, 1984; Apr. 29, 1985). The board and MOVA's functions originally included overseeing collection of funds from convicted criminal offenders and distribution of these grants for state victim services programs created by the act. These state Victim Witness Assistance Fund formula grants largely supported victim/witness assistance programs administered by district attorneys. Grant funds were also used to support the board, MOVA, Parole Board and attorney general victim assistance programs, and direct financial assistance to victims. Board oversight of the fund grants was discontinued per St 1991, c 138, s 212, which allocated appropriations directly to the state offices running the programs.

MOVA continues to administer the Massachusetts portion of the formula grant Victim Assistance Program created by the federal Victims of Crime Act of 1984 (VOCA), using monies collected by the federal Crime Victims Fund. The board and MOVA together review and approve funds given to community-based programs, usually nonprofit direct service and state agencies that help victims (and witnesses) of various crimes including child and elderly abuse, domestic violence, sexual assault, homicide, and drunk driving. Grants provide specialized services including counseling, support groups, advocacy, crisis intervention, training, and direct victim compensation.

MOVA also works with the board in the areas of advocacy, legislation, public policy, training, education, and outreach and acts as a resource to public officials and the interested public. It provides direct support to victims and their families through information, referrals, and crisis counseling.
