Record Group Name: Special Commission to Study Public Financial Aid to Nonpublic Primary and Secondary Schools and Certain Related Matters

Historical Note:

In response to concerns about declining enrollments in nonpublic schools, particularly Roman Catholic schools, Resolves 1969, c 61 provided for the creation of a special commission to investigate the possibility of granting public financial aid to nonpublic primary and secondary schools. The commission was to consist of three members of the Senate, seven members of the House of Representatives, the attorney general (or designee), the commissioner of education (or designee), the superintendent of schools of the Roman Catholic Archdiocese of Boston, and twenty persons to be appointed by the governor. In particular the commission was directed to consider the degree of need for public aid to nonpublic primary and secondary schools, the effects on public schools and local tax rates of the closing of nonpublic schools, providing public aid to nonpublic schools, the cost of providing aid, the need to impose public standards and regulations on nonpublic schools receiving aid, and the possible proliferation of nonpublic schools resulting from public aid. The commission was also to study possible alternatives to financial aid, the effects in other states of granting public financial aid to nonpublic schools, and implications for such aid of certain provisions of the constitutions of the United States and of the Commonwealth. The commission was directed to report to the General Court on or before the first Wednesday of January 1971.

During 1970 the commission, with Senator Andrea Nuciforo as chair, gathered information, held meetings of commission members and public hearings, and worked with the Institute for Educational Development, which prepared the final report. The commission focused on identifying reasons for declining enrollments in Roman Catholic schools, exploring alternative ways of granting aid, and studying the constitutionality of granting different kinds of aid. Proposed legislation resulting from the commission's work, including 1970 S 1278, was never enacted and the commission was disbanded the same year, with its report being issued in 1971.

Record Group Name: Commissioners to Ascertain the Boundary Line between Massachusetts and Rhode Island

Historical Note:

The name cited above and variations thereof were used for various bodies that investigated the boundary dispute between Massachusetts and Rhode Island during the 18th and 19th centuries. The history of that dispute is given below.

The boundary line between the states of Massachusetts and Rhode Island was in dispute until agreement was reached on the northern portion of the boundary in 1883 (St 1883, cc 113, 154). The eastern portion of the boundary was defined in 1861 by a decision of the U.S. Supreme Court in a case initiated by Massachusetts. The state's Topographical Survey Commission was authorized to survey and mark the boundary line in 1897 (Resolves 1897, c 88; Resolves 1898, c 7). The latitude and longitude measurements of markers set during the survey were then legally established by Massachusetts (St 1899, c 476) and Rhode Island.

The boundary was a point of contention dating back to colonial times. In 1741 a case was heard before the English Court of Commissioners pertaining to boundary issues. After independence from Britain was achieved, the boundary question again became subject to debate. Successive commissions were appointed or authorized and instructions issued by the General Court in 1791 (St 1790, c 30), 1801 (Resolves 1800, c 142), 1810 (Resolves 1809, c 71), 1818 (Resolves 1817, c 93), and 1825 (Resolves 1824, c 89) to deal with this dispute. With no resolution accomplished, a suit was brought to the U.S. Supreme Court by the state of Rhode Island in 1831. The governor of Massachusetts was authorized to employ legal counsel to answer before the court (Resolves 1832, c 78), which eventually dismissed the case in 1845.

While the boundary case was before the Supreme Court both states asserted rights to territory through their own legislatures. In response to a Rhode Island bill regulating shellfish harvesting on land claimed by Massachusetts, new Massachusetts commissioners were authorized (Resolves 1844, c 41; Resolves 1845, c 10) to again work with Rhode Island commissioners to define the eastern boundary line. The Massachusetts commissioners employed a surveyor (Resolves 1845, c 102) and procured early historical documents from Britain relating to the boundary (Resolves 1845, c 118). With agreement between the states in sight, Massachusetts commissioners were authorized, in conjunction with their Rhode Island counterparts, to mark the complete boundary (Resolves 1846, c 115). An agreement was reached in 1846 and the northern boundary was spelled out by the General Court of Massachusetts in 1847 (Resolves 1847, c 51). One member of the three-member Massachusetts commission dissented from the agreement insofar as the eastern boundary was concerned, and issued a minority report to the legislature. His view was shared by town residents along the newly defined border, who petitioned legislators to annul the commissioners' agreement.

This was done by Resolves 1848, c 75, which also provided that the governor appoint new commissioners to try once more to resolve the eastern boundary question. If they could not come to agreement by May 1, 1849, the governor was to bring a case before the U.S. Supreme Court (Resolves 1848, c 75), which was done in the court's December 1852 term. Meanwhile the General Court had authorized the removal of all monuments provided for in 1846 (Resolves 1852, c 61). While the case was before the court the Massachusetts attorney general was authorized to negotiate with Rhode Island (Resolves 1859, c 69) and a compromise was reached between the states while the case was pending; the Supreme Court issued a decision on December 16, 1861 conforming to the agreement, thus settling the eastern boundary, from Burnt Swamp Corner, Wrentham to the Atlantic Ocean.

The status of the boundary from the Connecticut line to Burnt Swamp Corner, Wrentham was still unclear. A letter from tax assessors in Bellingham raised the issue of the northern boundary in 1864, prompting the General Court to set a boundary through legislation in 1865 (Resolves 1865, c 52). The state of Rhode Island appointed a special commission to study the Massachusetts resolve and, determining that Rhode Island would be at a disadvantage if such a line were ratified, did not pass the necessary complementary legislation to establish the boundary. Rhode Island initiated a commission in 1881 to study the boundary line further. Massachusetts authorized the appointment of commissioners to join those of Rhode Island (Resolves 1881, c 27). When agreement was reached on the northern boundary by the joint commissioners in 1883, the long-standing discord between the states of Massachusetts and Rhode Island over a boundary line was ended.

Record Group Name: Commissioners to Ascertain and Establish the Boundary Line between Massachusetts and New Hampshire

Historical Note:

The name cited above and variations thereof were used for various bodies that investigated the boundary dispute between Massachusetts and New Hampshire during the 19th century. The history of that dispute is given below.

Commissioners were appointed by the governor of Massachusetts as authorized by the General Court in 1825 (Resolves 1824, c 93), to resolve disputes arising from the uncertain status of the Massachusetts-New Hampshire boundary, which had been determined by a decree of the king in council in 1740, then surveyed and marked in 1741. The Massachusetts commissioners met with their counterparts from New Hampshire but were unable to come to an agreement, leading the Massachusetts commissioners to disband in 1827. Their report to the governor was submitted to the legislature (Resolves 1826, c 73) and authorization was given to erect monuments along the existing boundary (Resolves 1826, c 97).

The boundary issue was raised again in 1883 (Resolves 1883, c 28), when the governor was authorized to appoint commissioners to meet with their New Hampshire counterparts to reset monuments along the boundary line. Commissioners were again authorized in 1885 for determining the true jurisdictional line between the two states and all previous laws relating to the boundary were repealed (Resolves 1885, c 73). Agreement on the eastern portion of the boundary was reached in August 1888 and funds were authorized to

carry out the commissioners' recommendations (Resolves 1889, c 108). Monuments were authorized to mark that portion of the boundary by Resolves 1890, c 73. The western portion of the boundary was settled in June 1894 and a tripartite agreement made with New Hampshire and Vermont in October 1894. The 1894 agreement was ratified by Massachusetts by Resolves 1895, c 106. Latitude and longitude measurements for boundary markers were defined and legally established by St 1899, c 369.

Record Group Name: Commissioners to Ascertain the Boundary Line between Massachusetts and Connecticut

Historical Note:

The name cited above and variations thereof were used for various bodies that investigated the boundary dispute between Massachusetts and Connecticut during the 18th and 19th centuries. The history of that dispute is given below.

After independence from Great Britain had been achieved, conflicts developed between Massachusetts and Connecticut over the legal boundary line between the two states, which had been defined by a colonial commission in 1713.

To resolve boundary questions, commissioners were appointed by the General Court in 1791 (St 1790, c 35) and replaced in 1801 (Resolves 1800, c 73). Additional instructions on negotiating with Connecticut were given to the governor in 1803 (Resolves 1802, c 96), and commissioners were redesignated to run and mark a boundary by St 1803, c 39. Agreement was reached on the boundary west of the Connecticut River in 1804 (Resolves 1803, c 102).

New commissioners to be appointed by the governor were authorized in 1820 (Resolves 1819, c 93), to define the boundary line east of the Connecticut River. The area was surveyed and a plan drawn in 1822 but Connecticut officials did not accept it. In 1823 the General Court empowered the governor to bring suit in a boundary-related dispute involving the town of Dudley (Resolves 1822, c 49), and later to communicate on a boundary solution with the governor of Connecticut (Resolves 1824, c 24), and to appoint new commissioners (Resolves 1825, c 9).

The new commissioners reached agreement with commissioners from Connecticut in November 1826. They submitted a report to the governor of Massachusetts in January 1827 detailing a final agreement on the line east of the Connecticut River, and the General Court requested the governor to issue a proclamation informing the citizens of Massachusetts of the boundary agreement (Resolves 1826, c 60).

The Topographical Survey Commission was authorized to examine the complete boundary and remark it in 1898 (Resolves 1898, c 39). Legislation was passed in Massachusetts (St 1908, c 192) and Connecticut (in 1913) legally establishing the latitude and longitude measurements of markers set by the commission.

Record Group Name: General Court – Committee on Accounts

Historical Note:

A committee of the House of Representatives of the Revolutionary Massachusetts General Court was ordered to examine all accounts payable, including militia muster rolls (House Journal, July 24, 1775), during the current session. Resolves 1775-76, c 384 (Nov. 10,

1775) enlarged the mandate for a successor committee to include (during session and recess alike) receiving, examining, and passing upon all accounts (i.e., on behalf of the whole House) presented for payment of services done or articles supplied by order of Congress or of the General Court and properly vouched. The committee was also to maintain a record of such accounts before sending them to the upper house (Council), which issued warrants for payment by the Treasury. Resolves 1775-76, c 426 (Dec. 8, 1775) reassigned the record-keeping function to the Council (which also had the power of concurrence per Resolves 1776-77, c 189 (July 4, 1776)); Resolves 1777-78, c 12 (June 5, 1777) transferred the function to a new House committee.

These committees were succeeded, with the establishment of the Constitutional General Court, by a joint standing committee of House and Senate (House Journal, Oct. 27, 1780; Senate Journal, Oct. 30, 1780; Resolves 1780, Oct Sess, c 11), variously referred to as auditing, examining, and settling public accounts, and known at least by 1782 as the Committee on Accounts. The committee was given authority from time to time to pay accounts from funds authorized by the General Court (i.e., to direct the governor and council to draw a Treasury warrant) (e.g., Resolves 1782, Jan 1783 Sess, c 154, which reinstated the committee after its temporary abolition as of Jan. 1783, per Resolves 1782, Sept Sess, c 34; Resolves 1784, May Sess, c 21). The committee eventually arrived at a settled procedure, as described several decades later in the Senate Journal (May 30, 1803), of examining all accounts exhibited for support of indigent persons by law the charge of the Commonwealth, and all other accounts for services performed, cash advanced, or any property supplied for use of the Commonwealth, and making out a corresponding roll (Resolves 1786, Sept Sess, c 128; also Resolves 1792, May Sess, c 15). The roll was arranged by categories listing names of persons or towns whose accounts were to be vouched, with sums found due, and laid before the General Court for its approval, which then requested a warrant. Such a roll was usually prepared at least once per legislative session.

Until 1829 the committee members were awarded special stipends for their service. In that year (Resolves 1829, c 11) responsibility for examining and auditing accounts other than for paupers and the military was transferred to the treasurer of the Commonwealth. The Committee on Accounts resumed this function per Resolves 1846, c 75.

St 1849, c 56 established the office of Auditor of Accounts (chosen by the General Court, but later made an elective office per Const Amend Art 17, ratified 1855), which not only assumed the committee's function in approving account rolls, but also that of the General Court in directing the governor and council to draw warrants for their payment. The auditor's books and accounts were, however, to be examined by the Committee on Accounts each January.

St 1867, c 168 repealed this last provision (as found in GS 1860, c 15, s 8), and two years later the committee was discontinued by a change in the General Court's joint rules (Senate/House Journals, Jan. 9, 1869)

Pursuant to Resolves 1824, c 99 (1825), the governor appointed three commissioners to ascertain the practicability of making a canal from Boston Harbor to the Connecticut River, and, if that were feasible, to investigate extending it to the Hudson River near its junction with the Erie Canal. Plans, surveys, cost estimates, and a detailed report were to be

returned to the legislature. Compensation for the commissioners and their engineers was addressed in Resolves 1825, c 22 and distribution of their report in Resolves 1825, c 71 (1826)

A preliminary report of the resulting Valley Forge Military Monument Commission was submitted to the governor by the chairman, retired Brigadier General Philip Reade, U.S. Army. The design for the monument was approved by the Massachusetts Art Commission on December 16, 1910, and the dedication at Valley Forge took place on November 18, 1911, ending the work of the commission.

Pursuant to Resolves 1865, c 62, the governor appointed five Commissioners on the Hours of Labor, to collect information and statistics on the issue and to report to the legislature.

Public hearing elicited testimony from manufacturers, union leaders, workers, and doctors notably Ira Steward, leader of the eight-hour work day movement. Bills filed by the commissioners to reduce hours and end labor by children under ten failed to become law.

Pursuant to Resolves 1866, c 92, the governor appointed three new commissioners to continue investigations, especially relating to the social, educational, and sanitary conditions of the industrial classes and prosperity of productive industry in the state, to report to the governor by the end of the year. They distributed a questionnaire in October 1866.

The commissioners' work led to enactment of legislation forbidding employment of children under ten in factories (St 1867, c 285) and that creating the Bureau of Statistics of Labor (Resolves 1869, c 162).

Massachusetts had unlimited claims on lands west of the Hudson River, based on provisions of the Plymouth Colony (1620) and Massachusetts Bay (1629) charters, while New York had competing claims based on provisions of the 1664 charter from King Charles II to his brother, James, Duke of York. After American independence, Congress urged that

boundary lines and land disputes between Massachusetts and New York be settled. The boundary between the colonies of Massachusetts and New York (i.e., east of the Hudson River--for lands west of the Hudson see: Massachusetts. Office of the Secretary of State. Agreement between Massachusetts and New York relating to western lands, 1784-1793 ((M-Ar)31X)) was to have been settled by an agreement signed at Hartford, May 18, 1773, but the actual line had not been ascertained pursuant to that agreement. St 1784, c 1 (June 4, 1784, replacing St 1783, c 61, Mar. 18, 1784, which erroneously dated the agreement as 1772) appointed Joseph Hawley, Caleb Strong, Timothy Edwards, and Theodore Sedgwick (member of the Continental Congress) commissioners to meet with their New York counterparts to ascertain the boundary and to adjudicate title claims of private landholders affected thereby. Negotiations had broken down by November 1784, and Resolves 1784, Jan 1785 Sess, c 116 (Mar. 11, 1785) authorized the delivery of commissioner reports to agents who would represent the claims of Massachusetts in federal court.

On June 29, 1785, Congress appointed commissioners of its own to settle the dispute (Thomas Hutchins, John Erving, and David Rittenhouse as of Dec. 1785). In Massachusetts, Resolves 1785, Feb 1786 Sess (Mar. 14, 1786) appointed Edwards, Sedgwick, and Jahleel Woodbridge agents to assist them, again with the collaboration of New York agents. St 1786, c 8 (June 27, 1786) reiterated this arrangement, this time with Edwards, Strong, Woodbridge, and Dr. Samuel Williams as agents. Massachusetts gave Congressional commissioners additional time to complete their mandate (St 1786, c 70, Mar. 1, 1787), and an agreement with both states was completed on July 21, 1787. Resolves 1787, Oct Sess, c 101 (Nov. 21, 1787) directed the agreement and accompanying papers to be filed with the state secretary (actually now found in: Passed resolves ((M-Ar)228))

The Massachusetts Bay Colony Tercentenary Commission was established by Resolves 1929, c 35 to plan the Commonwealth's celebration the following year of the 300th anniversary of the colony's founding. The nine gubernatorial appointees were also to recommend a memorial to commemorate the colony's founders.

The General Court appropriated, under the commission's auspices, 2,000 separate events took place in 250 municipalities, attended by 11 million citizens, including pageants, patriotic and thanksgiving services, historical exercises, and old home weeks. The main official commemoration, arranged by the commission, was the Great Meeting at the State Tribune erected on the northwest corner of Boston Common, held July 15, 1930. The commission's publications were entitled: Massachusetts on the sea and Pathways of the Puritans, and the Department of Public Works erected iron signs and other markers in ninety-six municipalities to indicate over 200 places and events significant in the early history of Massachusetts (Resolves 1930, c 10).

With the authorization to use unexpended 1930 appropriations to print additional copies of its publications (Resolves 1931, c 25), the commission's work was completed.

The commission was successively continued by Resolves 1954, c 121 (reporting in Jan. 1955 (1955 H 2417)) and Resolves 1955, c 89 (reporting in Jan. 1956) to consider the appendix to the minority section of the 1954 report.

The Uniform Commercial Code had originated in 1942 as a joint project of the American Law Institute and the National Conference of Commissioners on Uniform State Laws, in which Massachusetts participated pursuant to St 1909, c 416. The code was promulgated in 1951, first adopted in Pennsylvania in 1953-1954, and since then in all other states. The Massachusetts version of the code was eventually adopted as St 1957, c 765, now MGLA c 106. (At that time another commission was established to study amendments to the code (St 1957, c 765, s 20); it was continued by Resolves 1958, c 46 (see also c 97), and its recommendations incorporated in St 1958, c 542)

St 1827, c 116 (1828) superseded these bodies with a nine-member Board of Directors (or Commissioners) of Internal Improvements appointed by the General Court to further investigate rail construction on previously proposed routes, appointing engineers to survey and stake out such routes, accepting land gifts or grants, entertaining proposals of individual or corporate contributions, and negotiating with governments of or parties within the states of Rhode Island and New York.

Reports by these bodies were filed with the General Court, 1828-1830, after which their functions evidently lapsed until assumed by the Board of Railroad Commissioners in 1845.

The board was to be provided with relevant statistics and other data by state and municipal agencies; to create questions on tramps, vagrants, and unemployed laborers to be incorporated by the Bureau of Statistics of Labor into the 1895 state census; to consult park, water, and other state and municipal agencies regarding opportunities for increased public employment; and to cooperate with county and municipal authorities in devising methods of distinguishing confirmed vagrants from those willing to work and of securing a uniform system of registration and investigation of qualifications of those seeking employment. A final report (1895 H 50) as mandated was issued Mar. 13, 1895 (cf. Resolves 1895, c 5)

At the request of the United States Geographic Board, Governor Fuller appointed the Massachusetts Geographic Board on November 2, 1926. The purpose of the board was to provide the authoritative spelling, pronunciation, and definition of names of localities and natural features in Massachusetts. This work was to be incorporated in a gazetteer published by the United States Geographic Board.

The governor appointed the five-member board, which included the assistant librarian of Harvard University and the state archivist. A staff person was hired by the board to compile the results of research, which was done by contacting local authorities and historians in order to obtain the necessary information. A special effort was made to obtain the history of Indian names used in the state. When the information was compiled it was put on index cards.

In June 1932 over 6,000 name entries were mailed to the United States Geographic Board. Although the state board resigned upon completion of the survey, the secretary of the board remained available to answer any questions that might arise concerning the information collected. Correspondence continued through 1936 between the secretary and the United States Geographic Board and its successors.

Historical Note:

The governor and council commissioned a survey of the Commonwealth in 1830 in order to prepare an accurate map of the state (Resolves 1829, c 58). Originally the survey was to have had two components, trigonometrical and astronomical. A third component, a geological survey was added by chapter 18 of the Resolves of 1830. A preparatory step to the survey was legislation (Resolves 1829, c 50) requiring towns to survey their territory and submit maps to the secretary of the Commonwealth.

The trigonometrical, astronomical, and geological surveys were carried out each by its own field team working separately and reporting directly to the governor. When field work was completed the surveyors calculated and prepared data to be used in the state map. Robert Treat Paine worked on the astronomical observations from 1831 to 1838. Triangulation work for the trigonometrical survey was begun in 1831 and completed in 1838. Further field work was carried out until 1840 on a traverse survey of roads to refine information on town survey maps. James Stevens and then Simeon Borden were in charge of the trigonometrical work. The geological survey was conducted by Edward Hitchcock from 1830 to 1832. An initial geological report was issued in 1832 and a complete report in 1833. A second edition of the report was issued in 1835.

In 1837 (Resolves 1837, c 73) a further geological survey was commissioned, which was to include an investigation into coal and mineral resources in the state and to analyze soil for agricultural purposes. The requirement of a soil analysis was repealed in 1841 (Resolves 1841, c 14). A final report on the second geological survey was issued that year. The

survey as a whole has been referred to as the "Borden Survey" after Simeon Borden; the geological survey has been referred to as the "Hitchcock Survey" after its researcher, Edward Hitchcock.

Calculations from trigonometrical measurements and astronomical observations were used to establish geographic positions throughout the state. The calculated latitude and longitude of these positions were used to provide data for a map of the state, to establish a base for future surveys, and to provide information to surveyors measuring town boundaries. Engineers and surveyors working on private projects such as mapping real estate plots or laying out railroad routes would also be able to use the base points. Mariners would be able to use points along the coast for improved navigation and astronomers would be able to use corrected data for their observations. A table of bearings, distances, latitudes, and longitudes from calculations of the astronomical and trigonometrical surveys was published in 1846 to provide easy access to those wanting to make use of the data.

The astronomical, trigonometrical, and geological information was ultimately incorporated into a state map. Simeon Borden oversaw the work of projecting the map. A contract was put out for the engraving of plates needed to publish the map (Resolves 1841, c 43) and the survey office was closed by April 1842. A contract for the publishing of the map was authorized in 1844 (Resolves 1844, c 69).

Resolves 1916, c 107 provided for a successor Pilgrim Tercentenary Commission of five gubernatorial appointees to effect the earlier body's recommendations for improvement of historical localities, construction of a memorial hall, and holding of a pageant; and to investigate holding an international exposition as recommended in the governor's message of Mar. 1916 (this task given to another commission per Resolves 1920, c 53), and cooperation by federal, other state, and foreign governments, societies, and individuals regarding memorials and celebration, with a report to be issued in 1917.

Sp St 1919, c 187 authorized commission appropriations to acquire (by gift, purchase, or eminent domain) Plymouth lands and buildings, to carry out construction and improvements on these and other historic sites, and to contract with localities for their future care and maintenance; to erect a canopy over Plymouth Rock; and to arrange for a historic pageant. St 1920, c 392 authorized erection of signboards and milestones. A final commission report was submitted to the governor and council in 1924.

The Cambridge Bridge Commission was established, pursuant to St 1898, c 467, to administer construction of a bridge spanning the Charles River between Boston and Cambridge, to be known as the Cambridge (later Longfellow) Bridge. The commission consisted of the mayors of Cambridge and Boston and their joint appointee. The bridge, originally conceived as a drawbridge, became the first fixed span bridge on the Charles River (St 1899, c 180), and was intended to accommodate all forms of travel including private cars and elevated cars of the Boston Elevated Railway Company. (An additional commission responsibility was the rebuilding of the Soldiers' Field (now Larz Andersen) Bridge, also across the Charles River between Boston and Cambridge, pursuant to St 1904, c 412.) The termination date of the commission is unknown, but there are no surviving documents using its name (alternatively Boston and Cambridge Bridge Commission) after 1912. Responsibility for replacing or rebuilding Charles River bridges in the Metropolitan Parks District (Boston and surrounding communities) was assigned by St 1910, c 628 to the Metropolitan Park Commission.

Historical Note:

Following substantial appropriations by the General Court in 1931 for the emergency relief of unemployment in the Commonwealth, Governor Joseph B. Ely informed the press that an

Emergency Committee on Unemployment had been formed "to consolidate the efforts of the cities and towns of Massachusetts to provide or obtain employment for our people, and for the purpose of cooperating, of harmonizing and, thereby, of strengthening their efforts to supply assistance to those who may be in need." The committee of eleven members was chaired by William Phillips, former regional director of the New England Territory on the President's Emergency Committee for Employment. Other members of the committee had served on the 1930-1931 Massachusetts Emergency Committee on Unemployment (Resolves 1930, c 60). The state was divided into seven regions and seven regional vice-chairmen were added to the committee. They were responsible for the organization of work in each district.

The primary responsibility of the committee was to insure that no community was confronted with a relief problem larger than it could handle. The committee followed the policy established by the president's committee and the state committee of 1930-1931 that there should be no central board or source of relief and that all work should be carried out on a local basis. To implement this policy the committee was to create, encourage, and guide local unemployment committees where they were needed to supplement the work of the Department of Public Welfare. Such committees were organized in all but three of the 355 cities and towns in Massachusetts.

The committee's work also included studying national and state relief efforts on unemployment, interpreting state laws, recommending legislation that gave priority to the employment of those with dependents, and in general researching legal issues pertaining to the unemployed. It contacted industrial leaders urging them to suspend seniority rules and to have the maximum number of people working even if pay cuts resulted. The committee also urged cities and towns not to curtail recreation programs and assisted in developing programs that included planting vegetable gardens; clothing drives in cooperation with the army, the Red Cross, and business leaders; a job drive by the American Legion; and benefit performances in motion picture theaters.

Under the committee's auspices, an Educational Committee of local institutions was formed to implement cooperative university courses for 1,600 unemployed white-collar workers. That committee's members included the state Department of Education, the Boston Public Library, the Boston School Committee, Boston University, the Boston YMCA, Harvard University, Massachusetts Institute of Technology, the Museum of Fine Arts, the North Bennet Street Industrial School, Northeastern University, Radcliffe College, Simmons College, Tufts College, and Wellesley College. Classes were both practical and cultural and included the following: accounting, business English, finance, journalism, art appreciation, music, choral singing, retail selling, industrial art, pottery, and leathercraft.

In 1932 the work of the Massachusetts Emergency Committee on Unemployment was completed and the body disbanded.

Historical Note:

The first legislation regulating the Massachusetts Indians (St 1693-4, c 17) provided that the governor appoint "one or more discreet persons...to have inspection and more particular care and government of the Indians in their respective plantations." Fifty years

later (St 1746-7, c 12) the General Court began to appoint "near to every Indian plantation in the province, guardians to the said Indians," three to a plantation, empowered to take Indian lands, redistribute them among the Indians, let out the remainder, and use the resulting income to provide for sick and indigent Indians, with accounting of these transactions to be presented to the legislature. Although Indians were not then restricted from selling their land, the renewal of the act (St 1758-9, c 6) put such sales in the hands of the guardians.

Regular renewals of the legislation occurred until 1796, but chapter 69 of that year fails to include it among expiring acts being made perpetual. Nevertheless, appointment and removal of guardians and approval of their accounts and proposed land sales to support the Indians were continued routinely by the General Court. Special regulations followed: to convey guardian accounts to the Committee on Accounts (Resolves 1801, c 17); to have guardians give bond and an account of properties held in trust to the Court of Sessions (St 1824, c 123); to provide for guardians' removal from office for cause by the governor (St 1846, c 216); and for the review of their accounts by judges of probate (St 1850, c 141). -- Guardians, sometimes referred to as trustees, were by the mid-1700s associated with at least two dozen localities, of which the following were governed through special legislation:

(1) Marshpee (Mashpee) was made a district (St 1763-4, c 3) in which "Indians and molattoes, proprietors" elected five overseers (two of them "Englishmen") to function as guardians; the district was then abolished and guardians appointed by the General Court were reimposed (St 1788, c 2), this followed quickly by a new gubernatorially-appointed board of overseers (St 1788, c 38); they would themselves appoint guardians, whose responsibilities were extended to the Herring Pond Indians as well (Resolves 1789, May Sess, c 23). Later, overseers were empowered to act as guardians themselves (St 1818, c 105). The district was reestablished (St 1834, c 166) after an Indian uprising, with the governor appointing a commissioner who replaced the overseers, and in Mashpee (though not at Herring Pond) worked with selectmen chosen by the Indian proprietors. The commissioner was replaced with a gubernatorially-appointed treasurer (St 1853, c 186); next the proprietors were allowed to propose the treasurer to the governor (St 1856, c 286), and eventually to elect him (St 1863, c 183).

(2) Gay Head was to have its guardians appointed by the governor (St 1811, c 78) as were

(3) Natick (Resolves 1809, c 125), (4) Grafton (Resolves 1827, c 78), and (5) Dudley (Resolves 1828, c 62). (6) Chappaquiddick and Christiantown in Dukes County were to receive gubernatorially-appointed guardians (St 1827, c 114), who governed with overseers chosen by the Indians, provisions of this act being extensible to Gay Head should those Indians accept it, which they did not.

That fact was noted by John Milton Earle, in an 1861 report (1861 S 96) commissioned by the governor as provided by an act (St 1859, c 266) to extend citizenship conditionally to Indians. Coming after another commissioned report (Resolves 1848, c 82), Earle's generally negative account of the Indians' condition concluded by proposing automatic enfranchisement of all Indians but those of seven plantations (Chappaquiddick, Christiantown, Gay Head, Mashpee, Herring Pond, Fall River, and Dudley), they being allowed individually to become citizens on payment of poll tax. Earle's recommendations were largely enacted (St 1862, c 184), except for the proposal of a state-wide commissioner: the guardians for four plantations remained intact, while Gay Head was set up as a district on Mashpee's model. A few years later franchise was extended to all Indians remaining under guardians (St 1869, c 463), with probate judge-appointed commissioners disposing of remaining common lands, and the indigent being placed under the care of the Board of State Charities. Mashpee and Gay Head were incorporated as towns (St 1870, c 293, 213) and the Board of State Charities examined and closed the accounts of the last guardians of Indians (Resolves 1870, c 80).

Massachusetts paid for many expenses in fighting the Revolutionary War, especially during the 1775-1776 period when Washington's army and the British army were in the Boston area. These expenses included soldier's pay and bounties, clothing, medical and other supplies, ships, arms, coastal defense as well as support to towns for refugees (the poor) of Boston and Charlestown. Expenses, taken from collected vouchers and receipts, warrants, Council minutes, and other sources, were compiled into books, divided into categories, and often broken down by roll (list) and roughly arranged by date paid by the state. They were then submitted to the federal government for reimbursement. Massachusetts had sought such reimbursement from early on, but final settlement of these accounts did not take place until 1793.

Reimbursement was a lengthy process caused by financial difficulties of the new federal government and the complications of establishing methods of receiving, organizing, exhibiting, and getting approval of expenses. Initially, a committee of the General Court prepared two books of disbursements (war expenses covered by the Massachusetts government) paid out during the years 1774-1775 and 1775-1776. These were submitted to the Continental Congress by Joseph Henderson, but reimbursement was not forthcoming. Another committee was appointed per Resolves 1777-78, c 563 (Dec. 13, 1777) to determine and prepare disbursements made since Dec. 31, 1776, for additional submission.

A joint committee for stating and methodizing public accounts was first established per Resolves 1777-78, c 974 (Apr. 20, 1778). It was responsible for reviewing accounts and collecting vouchers for all of the various sections of the government from the time of the Provincial Congresses onward to determine the state of the public accounts in Massachusetts. Per Resolves 1778-79, c 433 (Feb. 3, 1779), responsibility for disbursement submission was also given to this committee, as the Dec. 13, 1777 committee had not yet fulfilled its charge. The form of the committee varied over the years; usually John Deming and Peter Boyer were members. (For examples of specific mandates to the committee relating to its original mission see Resolves 1787, May Sess, c 113 (where it is called the Committee on Methodizing Accounts) and Resolves 1787, Oct Sess, c 107). Eventually Deming alone was appointed to continue receiving and collecting claims against the United States (Resolves 1790, May Sess, c 77, June 23, 1790), and was later involved in

certifying amounts owed to various persons for Revolutionary War expenses. He was officially discharged as of July 15, 1794, per Resolves 1794, May Sess, c 36 (June 17, 1794)

Congress, per a resolve of Feb. 1782, called for states to submit expenses (within a six-month deadline, per an ordinance of May 7) and appointed commissioners to review and settle such submissions; those responsible for Massachusetts claims were, successively, William Imlay, 1783-1785, Royal Flint, 1785-1787 (see: Massachusetts. Office of the Secretary of State. Massachusetts archives collection ((M-Ar)45X), v. 288, p. 220-224), and Col. Haskell, 1787-1788. They reviewed and approved previously submitted accounts as well as current submissions, and issued Massachusetts interest-bearing certificates as reimbursement. Per Resolves 1789, Jan Sess, c 154 (Mar. 8, 1790), Nathan Dane was appointed agent to represent Massachusetts in settling its claims against the federal government before a board of commissioners appointed by Congress. Dane continued to collect additional claims for Revolutionary War expenses through Deming. By 1792 the time for exhibiting accounts to Congress had expired, and in 1793 a final settlement between the federal government and the various states was reached.

Historical Note:

During the early stages of the Revolutionary War in Massachusetts, its third Provincial Congress's Committee of Safety directed certain persons to provide rebel troops with wood and hay taken from abandoned loyalist estates (Journals, July 5-6, 1775). The reconvened General Court directed that wood be provided on the same basis (Resolves 1775-76, c 50, Aug. 4, 1775).

Because this ad hoc process proved inadequate (Council to Gen. George Washington, Oct. 26, 1775, Massachusetts archives collection, v. 138, p. 253), the legislature established a committee (with no formal name) to supply wood to the Continental Army (Resolves 1775-76, c 342, Nov. 4, 1775). The committee was empowered to hire and pay ax-men and teamsters, and to procure wood and hay either by purchase or by seizure, and to oversee delivery to troops.

Towns were to supply wood to camps at Roxbury, Cambridge, Winter Hill, and Prospect Hill (House Journal, Dec. 2, 1775). In several instances (Lincoln, Bedford, Natick, Dedham) the legislature altered the required amount if the town had supplied troops, and vice versa (Resolves 1775-76, c 413, Dec. 4, 1775; c 414, Dec. 5, 1775; c 423, Dec. 8, 1775)

Given the still continuing insufficiency of wood supplies, Resolves 1775-76, c 461 (Dec. 5, 1775) increased committee membership from seven to eleven; it also allowed the committee to make compulsory purchases of wood and to arrest anyone interfering with its functions.

Per Resolves 1775-76, c 451 (Dec. 20, 1775), towns were to provide hay to camps at Cambridge and Roxbury at a set rate of reimbursement. (This resolve was administered by a separate committee.) Having the same difficulty as with wood, the legislature increased the rate and empowered town selectmen to impress the hay if necessary (Resolves 1775-76, c 517, Jan. 16, 1776)

Resolves 1775-76, c 651 (Feb. 14, 1776) and c 722 (Mar. 20, 1776) increased committee funding. Resolves 1775-76, c 824 (Apr. 12, 1776) directed the committee to settle its account with the quartermaster of the departing Continental Army, using funds so acquired to reimburse the Massachusetts Treasury. A supplemental grant for this purpose was provided by Resolves 1776-77, c 31, June 11, 1776, ending the work of the committee.

Original committee members were Richard Devens (chair), Samuel Thatcher, Abner Ellis, David Cheever (treasurer and clerk, Jan. 4, 1776), Ebenezer Thayer, James Barrett, and Eleazer Brooks. Brooks and Barrett excused themselves on Nov. 6 and Nov. 10, 1775 and were replaced respectively by Jonas Dix and Timothy Walker. Additional members as noted above were Daniel Vose, Benjamin Guild, Jonas Stone, and Ebenezer Withington.

It consists of three judges appointed by the Supreme Judicial Court, three members of the bar appointed by the chief administrative justice of the Trial Court, and three persons appointed by the governor. The functions of the commission are currently outlined in MGLA c 211C, added by St 1978, c 478, s 114, as amended.

During the French and Indian War, the inhabitants of the British colony of Nova Scotia known as Acadians were considered of dubious loyalty because of their French origin. Following the British capture of Fort Beauséjour from the French in the spring of 1755, orders were issued to remove these so-called French neutrals from their homes and to transport them to other British colonies, including Massachusetts, Connecticut, New York, Pennsylvania, Maryland, Virginia, the Carolinas, and Georgia.

Upon the arrival of French neutrals in Massachusetts, its General Court appointed a joint committee (Resolves 1755-1756, c 186 (Nov. 7, 1755)), to direct their disposition in the province. Per St 1755-56, c 23 (Dec. 24, 1755), county courts, justices of the peace, local overseers of the poor, or selectmen were directed to employ, bind out, or support such individuals as they would any town inhabitant, but also, as would not be the case for their own indigent citizens, to submit accounts of expenses incurred thereby to the provincial secretary for reimbursement until Apr. 10, 1756.

A second joint committee was appointed per Resolves 1755-56, c 235 (Dec. 27, 1755), to oversee these arrangements until further direction was received from Nova Scotia governor Charles Lawrence or the province's own governor, William Shirley, presently commanding British forces. (A committee appointed per Resolves 1756-57, c 351 (Feb. 14, 1757) did extract a commitment from Lawrence to reimburse the province (c 386 (Feb. 19, 1757; see also Resolves 1756-57, c 521 (Apr. 16, 1757) and Resolves 1757-58, c 327 (Jan. 24, 1758)). The exiles were to remain provincial charges, and their presence in the various towns was not to render them legal inhabitants thereof. These provisions were confirmed on Jan. 16, 1756 (Resolves 1755-1756, c 239) and again on Jan. 24 (Resolves 1755-1756, c 248). St 1755-56, c 35 (Mar. 6, 1756) directed local officials to supply work tools and housing to those exiles who were willing to be self-supporting, and relief to those incapable of work, again submitting accounts to the province for reimbursement of related expenses each June 1, through June 20, 1757. (The act was renewed per St 1757-58, c 7 (June 16, 1757) until Aug. 1, 1757; see also Resolves 1756-57, c 188 (Oct. 13, 1756))

An order of Council (Leg Recs 21: 186 (May 28, 1756)) concurred with by the House appointed a joint committee to reconsider the fate of the French neutrals; its recommendation was that they be allowed to remain in the province (Resolves 1756-57, c 2 (May 28, 1756)). Whereupon a joint committee to examine charges for support of French neutrals was established per Resolves 1756-57, c 15 (May 31, 1756). It was responsible for reviewing all accounts submitted for the support of French neutrals, as well as for proposing some method of easing the charge to the province, and consisted of Council members Samuel Watts and William Brattle and House of Representative members Samuel Welles and (per Resolves 1756-57, c 32 (June 8, 1756)) Joseph Gerrish and Thomas Clapp.

As recommended by this committee, Resolves 1757-58, c 377 (Mar. 18, 1758), provided that the province was through local government to continue to provide housing, and to provide support to the sick, infirm, and aged French neutrals, but that others were to be self-supporting after Apr. 15, 1758. House members were to survey the condition and capabilities of French neutrals in their districts and report back to the General Court at the next session. These provisions were reiterated in Resolves 1758-1759, c 32 (June 14,

1758). Meantime, the 1756 committee was apparently replaced by one of councilors only (Watts, Brattle, and John Chandler), per Council order of June 8, 1758 (Exec Recs 13: 406)

Resolves 1759-60, c 415 (Apr. 19, 1760) addressed the high cost of provincial support of the French neutrals by having them apportioned to the various counties and then towns in accordance with amount of taxes paid by each locality, and making the towns responsible for their support as with any other poor (see also Resolves 1759-60, c 457 (Apr. 25, 1760), and c 477 (Apr. 26, 1760), which adopted the committee report). Resolves 1760-1761, c 118 (Aug. 15, 1760) explicitly designated French neutrals as legal inhabitants of the towns in which they were located. In placing responsibility for support of French neutrals in the hands of the towns, the General Court effectively ended the work of the committee examining charges.

Historical Note:

Resolves 1775-76, c 738 (Mar. 25, 1776) established a committee of the Massachusetts General Court to take inventories of real estate and personal effects left by Loyalists departing Massachusetts during the American Revolution. Members of what was eventually known as the Committee of Sequestration, by 1779 identified solely as of the town of Boston, included Jonathan Browne (chair), William Cooper, John Pitts, and Josiah Sartell, with Elias Parkman as clerk. Resolves 1775-76, c 866 (Apr. 23, 1776) directed local committees of correspondence to take possession of estates in their areas left unattended by fleeing Loyalists, and lease them out. Resolves 1775-76, c 981 (May 4, 1776) directed the Committee of Sequestration also to lease out estates in its possession. The committee's additional responsibilities included paying expenses incurred in managing absentee property including fees to agents, auctioneers, and sheriffs, setting up public auctions of goods, and submitting auction and other monetary proceeds to the state treasury. The

committee also turned over confiscated supplies to the commissary as needed. Resolves 1778-79, c 531 (Feb. 19, 1779) directed both the Committee of Sequestration and the committees of correspondence to sell goods in their possession, in order to provide funds for the state to pay gratuities promised to soldiers.

Resolves 1779-80, c 1114 (May 5, 1780) appointed a committee to investigate proceeds of sales conducted by the Committee of Sequestration, as it had failed to report its accounts to the legislature. Resolves 1780, Oct Sess, c 95 (Nov. 29, 1780) appointed committees for each county to take charge of absentee real estate and personal effects from the Committee of Sequestration (see series (M-Ar)2505X), and to sell the same at public auction. Resolves 1780, Apr 1781 Sess, c 139 (May 7, 1781) appointed a committee to settle the accounts of the Committee of Sequestration and bring its business to a final close by June 10th under threat of prosecution by the new committee. In fact this was only the first of a series of committees appointed to this function, with final instructions from the General Court given to the Committee for Methodizing Accounts per Resolves 1783, Jan 1784 Sess, c 165 (Mar. 20, 1784) (see that entity's Disbursement books of Revolutionary War expenses, 1774-1790 ((M-Ar)2350X))

Historical Note:

Per St 1778-79, c 49 (May 1, 1779), the Massachusetts General Court authorized the confiscation and sale of absentee estates for the benefit of the government. Resolves 1778-79, c 312 (Sept. 23, 1779) appointed various county committees to sell at public auction estates confiscated from prominent Loyalists named in the resolve. County committee actions, reflected in resolves passed Oct. 1779-May 1780, included sales, suspended sales, leases, and receipts deposited into the Treasury. Some records for these committees are found in: Massachusetts. Office of the Secretary of State. Massachusetts archives collection ((M-Ar)45X), v. 280.

Resolves 1780, Oct Sess, c 95 (Nov. 29, 1780) appointed committees for each county to take charge of absentee real estate and personal effects from the Committee of Sequestration and to sell the same at public auction. Resolves 1783, Jan 1784 Sess, c 132 (Mar. 16, 1784) suspended sales of absentee estates and directed the committees to settle their accounts by June 10. As the treaty ending the Revolutionary War prohibited further confiscations, St 1783 c 69 (Mar. 24, 1784) specified that any absentee property not already sold or claimed for debt should be returned to its original owner.

Chicago, for an event that ran from April through October, 1893. --The Massachusetts General Court passed a resolve (Resolves 1891, c 98) establishing a Board of World's Fair Managers of Massachusetts, under whose auspices a non-permanent Massachusetts Building was erected to house exhibits of the arts, industries, institutions, resources, products, and general development of the Commonwealth of Massachusetts. Further resolves (Resolves 1892, c 63, c 79, c 97 and Resolves 1893, c 39, 88, 111) provided state grants and settled other fair-related matters. The costs and furnishings of the Massachusetts Building were significantly borne by private corporations within the state.
