#### **Historical Note:**

Commissioners were first appointed by the General Court in 1668, two for each county, to enforce equitable taxation while working with Court-appointed commissioners for each of the colony's four seaports (Mass Recs 4, pt. 2: 363-364). However, county commissioners in modern usage were provided for as gubernatorial appointees pursuant to St 1827, c 77 (1828), which assigned them administrative powers and duties exercised since 1781 at various times by county courts of general sessions of the peace, county courts of common pleas, and circuit courts of common pleas. Election of commissioners by the inhabitants of each county was authorized by St 1835, c 152. As codified in RS 1836 c 14, ss 31-37, county commissioners' responsibilities were to erect and repair jails, courthouses, and other county public buildings; to lay out, alter, or discontinue county highways; to grant and other liquor licenses; to estimate, apportion, and assess taxes for county charges and debts; and to examine and settle county accounts.

Currently three commissioners serving as a board are elected for four-year terms in each county except Nantucket, where their function is filled by the selectmen, and Suffolk, where it is filled in Boston by the mayor and city council, in Chelsea and Revere by their respective municipal councils, and in Winthrop by the selectmen (MGLA c 34, s 3). In each county the clerk of courts serves as clerk to the commissioners (MGLA c 221, s 3). However, county government including its commissioners has been abolished as follows: Franklin (1997), per St 1996, c 151, s 567, Middlesex (1997), Hampden (1998), and Worcester (1998), per St 1997, c 48.

Powers and duties of boards of county commissioners include the following:

- (1) preparation of an annual budget of estimated revenues and expenditures, which after a public hearing is forwarded to the advisory board on county expenditures (MGLA c 35, ss 28, 28B)
- (2) with the approval of the advisory board, levying, apportioning, and assessing taxes from cities and towns (MGLA c 35, ss 30-31)
- (3) approving all disbursements by the county treasurer, including county payrolls (MGLA c 35, ss 11, 19)

- (4) borrowing money for county expenses in anticipation of county revenues (MGLA c 35, s 37)
- (5) contracting for construction and maintenance at county expense of jails, which the commissioners inspect twice yearly, and of other public buildings, and, at state or local expense, for the construction and repair of highways (MGLA c 34, s 14, 17; c 35, s 34A; c 126, ss 1-2)
- (6) making rules, regulations, and orders governing purchasing, delivering and handling of, and contracting (by bid) for supplies, equipment, and services (MGLA c 34, s 17)
- (7) with the assent of local authorities, the acquisition (by purchase or eminent domain) or sale of county land (MGLA c 34, ss 14, 25)
- (8) laying out, altering, and discontinuing county highways and maintaining county maps (MGLA c 82, ss 1, 11; c 34, s 2)
- (9) preparation of an annual report listing petitions and actions regarding highways; repairs to public buildings; salaries paid to county officers; taxes due and unpaid; and assets of the county, including land, buildings, and furniture therein (MGLA c 35, s 26)

#### **Historical Note:**

Middlesex County was incorporated on May 10, 1643 (Mass Recs 2:38), continuing under successive governments of Massachusetts, most recently the Commonwealth (1780), as outlined in MGLA c 34. Administrative powers and duties previously exercised at various times under the laws of the Commonwealth by county treasurers and clerks of the county courts of general sessions of the peace, county courts of common pleas, and circuit courts of common pleas, were assigned to commissioners in Middlesex and other counties upon their establishment per St 1827, c 77 (1828). The government of Middlesex County was abolished as of the effective date of St 1997, c 48 (approved July 11, 1997).

#### **Historical Note:**

St 1746-47, c 15 made Taunton the shire town for Bristol County (instead of the Town of Bristol). The Taunton (i.e., Bristol County) Jail, originally in an old schoolhouse in Taunton (1746-1785), relocated to a stone structure on Court Street (1818-1873) and was replaced by the Hodges Avenue Jail (1873-1923). The Hodges Avenue Jail was no longer used as of 1920. -- St 1827, c 135 (1828) allowed citizens of New Bedford, Fairhaven, Dartmouth, or Westport to be tried in New Bedford, while citizens of any of the other towns were still tried in Taunton. The New Bedford jail was built on Court Street in New Bedford in 1829. St 1834, c 151 charged county commissioners with providing houses of correction for every county, and a house of correction was added to the jail beginning in 1835, with a new building constructed in the 1860s. Surviving records suggest that those committed for more serious crimes had already been so segregated from 1829. St 1886, c 152 and St 1886, c 215 called for county commissioners to enlarge the New Bedford complex by demolishing the jail and constructing an Ash Street facility. This operated as the primary location to house inmates from 1888 until specialized facilities for addiction and prerelease were constructed by 1990 at North Dartmouth, as part of a new jail/house of correction facility (see below). Today it is known as the Ash Street Jail and Regional Lockup.

Lizzie Borden was housed in the Hodges Avenue Jail (Taunton) in 1892-1893 while awaiting trial at the New Bedford Courthouse for the murders of her parents, Andrew and Abby. She was transported to the Ash Street Jail (New Bedford) for her arraignment in May 1893 and again for her trial in June 1893, when she was found not guilty.

St 1897, c 297 authorized construction of a jail in Fall River, which in fact never opened and was sold to the City of Fall River in 1915. The current Bristol County Jail and House of Correction was opened in North Dartmouth in 1990 to house male inmates of sentences of 2 1/2 years or less, high risk males and females awaiting trial, and pre-release and drug treatment programs. All programs for women were moved to the Bristol County Sheriff's Women's Center at the same site, added in 1999. Also located there is the Carreiro Immigration Detention Center.

#### **Historical Note:**

Massachusetts St 1799, c 81 established a municipal court to handle Suffolk County criminals, taking over from the Court of General Sessions. Any prisoners ordered committed or awaiting trial were to be committed to the custody of the keeper of the Suffolk County Jail, i.e., the town or so-called Boston gaol located since 1635 off Court Street. --Begun around 1819, the Leverett Street Jail opened in 1822. It was replaced by the Charles Street Jail in 1851. This was closed in 1991, replaced by the Suffolk County Jail on Nashua Street, which opened in 1990.

In October 1823, one of the two stone prison buildings, North Jail at Leverett Street, was converted into a house of correction, and employed inmates in hammering stone. St 1824, c 28 established the House of Correction in the City of Boston as the House of Correction for the County of Suffolk, under the control of the city. A new building was erected in 1825 at South Boston for the House of Correction, although the move to the new building was delayed.

In 1833, the City Council finally ordered the removal of the houses of correction on Leverett Street and on Governor's Island (fl. 1820-1833) to South Boston. The House of Correction was located in South Boston until 1896. St 1896, c 536 moved the House of Correction from South Boston to the former House of Industry on Deer Island, which was designated the House of Correction at Deer Island. In 1991 this facility was replaced by the Suffolk County House of Correction at South Bay, which opened on Dec. 26, 1991. St 1991, c 138, ss 356-363, placed the House of Correction in the charge of the Suffolk County Sheriff's Office.

#### **Historical Note:**

Middlesex County commissioners were authorized to build one or more truant schools per St 1892, c 273. Such a school was opened in 1894 at Chelmsford, later being moved to Lowell. Per St 1898, c 496, the Middlesex County school was to accept inmates from Revere, Winthrop, and Chelsea, while the Boston parental school (St 1886, c 282) functioned as the truant school for the rest of Suffolk County. Under the 1898 act

(amended by St 1903, c 330), children defined as habitual truants (between seven and fourteen), habitual absentees (between seven and sixteen), and habitual school offenders (under fourteen; under sixteen per St 1913, c 779 s 8) could, if boys, be committed for up to two years at a county truant school; or, in the case of absentees or offenders, to the Lyman School for Boys. (Girls were committed only to the State Industrial School for Girls at Lancaster.) County commissioners could grant and revoke parole from the truant schools. Truant school inmates guilty of gross misbehavior there could be sent (under fifteen) to the Lyman School or (fifteen or over) to the Massachusetts Reformatory.

St 1904, c 220 removed the two-year limit of truant school commitment, but specified sixteen as the latest age of release. St 1906, c 389 provided for commitment only to county truant schools of habitual truants, absentees, or school offenders. St 1913, c 779, s 11 provided that boys in county training schools (as they were now called per St 1908, c 103) guilty of gross misbehavior if over fifteen be sent to the Industrial School for Boys at Shirley rather than to the Massachusetts Reformatory.

In anticipation of the repeal of current law providing for the institutionalization of school and other youthful offenders (St 1973, c 1073, s 2), the Middlesex County Training School was closed in Feb. 1973.

#### **Historical Note:**

There is a registry of deeds for recording property ownership in each of the Massachusetts counties or registry districts within a county -- Essex, Middlesex, and Worcester counties are divided into two districts each; Berkshire and Bristol counties are divided into three districts each (St 1697, c 21, ss 1, 5; MGLA c 36, s 1). Each county or registry district elects for a six-year term a register of deeds to administer the registry (St 1783, c 60, s 1; MGLA c 36, s 2). As a part of the county government, registers relate to county commissioners for administrative matters.

Registers accept for recordation, deeds and other documents such as mortgages, liens, or plans that affect land in their district. Procedures for recordation are governed by statute (MGLA c 36, s 14). Deeds and instruments are processed in order of receipt, with grantors, grantees, and municipality where the land lies being recorded. The register copies each document, the original being returned to the individual filing it.

The register acts as the assistant recorder of the Land Court for his district (St 1898, c 562, s 10). The Land Court, a part of the judicial system, determines the actual state of the title

to land and operates the state's system of land registration. The record copy of its decrees and certificates of title to individual parcels of land is maintained by the register in a discrete location at the registry of deeds.

The register also relates to municipal, state, and federal governments in land-related matters, such as title, taxes, and liens. Upon request of the board of assessors of any municipality in the district, the register furnishes the board with copies of instruments recorded at the registry that affect the title to real estate in the municipality, or taxation of that real estate. Municipal planning boards are required to file subdivision control rules and regulations with the register; no rules and regulations are effective until such certified copies have been filed (St 1953, c 674, s 7)

The register notifies the state Dept. of Revenue when any declaration of trust is filed, and the state Dept. of Public Welfare when instruments creating charitable trusts are filed. The register keeps a current list of all taxpayers against whom federal liens have been entered. After a petition in bankruptcy is filed, the bankrupt, trustee, receiver, custodian, referee, or any creditor may file a copy of the petition at the registry. In order to enhance preservation of landmarks and sites, registers are required to record certification of an historic or archeological site and the withdrawal of such certification (St 1963, c 697, s 1).
