**Record Group Name: Executive Office of Environmental Affairs** 

#### **Historical Note:**

The Executive Office of Environmental Affairs was created by St 1969, c 704, s 3, as part of a major reorganization of the governor's cabinet, effective Apr. 30, 1971. The executive office, under the supervision of an appointed secretary, included the Dept. of Agriculture, the Dept. of Natural Resources (including the Division of Fisheries and Game, the Division of Water Resources and the Water Resources Commission), the Metropolitan District Commission; the Outdoor Advertising Division and Outdoor Advertising Board; the Milk Regulation Board, as well as various commissions, mostly concerned with state reservations. The specifics of this new executive office were detailed in MGLA c 6A, s 15. Section 50 of the 1969 act specified that the secretaries were to make recommendations for changes in the laws and departments in their executive offices within a two year period of appointment.

St 1974, c 806 reorganized the Executive Office of Environmental Affairs, placing it in a newly created MGLA c 21A. MGLA c 6A, s 15 was repealed per section 50 of the 1974 act, with the changes to take effect July 1, 1975. In its new form the executive office consisted of the Dept. of Environmental Protection (formerly Environmental Quality Engineering), Dept. of Environmental Management, Dept. of Fisheries, Wildlife, and Environmental Law Enforcement (formerly Fisheries, Wildlife, and Recreational Vehicles), and Dept. of Food and Agriculture (s 7); the Metropolitan District Commission (s 7), Coastal Zone Management Office (s 4A), Office of Geographic and Environmental Information (s 4B), Water Resources Commission (s 8A), and Massachusetts Water Resources Authority (MGLA c 92, App 1-1).

**Use Reduction** 

#### **Historical Note:**

St 1989, c 265, s 3 (Massachusetts Toxics Use Reduction Act, codified as MGLA c 21I) included a statewide goal of fifty percent reduction from 1987 to 1997 in quantities of toxic or hazardous byproducts generated by industry in Massachusetts (s 13), this effort to be under the direction of the Dept. of Environmental Protection. The Office of Toxics Use Reduction Assistance and Technology (currently known as the Office of Technical Assistance for Toxics Use Reduction) was established (s 7) to assist toxics users in complying with the law; to help establish (through the Administrative Council on Toxics Use Reduction) prioritization of user segments required to report annually on toxic/hazardous substances manufactured, processed, or otherwise used and to submit plan annually for reduction thereof (ss 10-11, 14); to provide outreach to small businesses

required to so report and plan; and to assist first-time filers with reporting requirements and trade secret submissions (s 20)

The office, established by law as within the Executive Office of Environmental Affairs (EOEA), was initially attached to and then superseded the Office of Safe Waste Management, Dept. of Environmental Management; then (by 1992) placed in the Bureau of Waste Prevention, Dept. of Environmental Protection; thereafter placed directly under the EOEA.

#### **Historical Note:**

In the 1700s local agricultural societies throughout Massachusetts promoted interest in husbandry. The Massachusetts Society for Promoting Agriculture (also known as the Massachusetts Agricultural Society) was created by St 1791, c 49. Subsequent acts and resolves (Resolves 1813, c 125 (1814) and Resolves 1816, c 141 (see: Massachusetts. Office of the Secretary of State. Records relating to agricultural societies ((M-Ar) 1047X)) issued

payments to the society for research, publication, and dispensing premiums related to domestic animals, seeds, trees, fabrics, and useful inventions.

Resolves 1837, c 67 ordered an agricultural survey of the state published as: Report of the Agriculture of Massachusetts, prepared by Henry Colman. St 1852, c 142 established the State Board of Agriculture to improve agriculture, promote agricultural education and general interests in husbandry. There were nine original committees of the board that addressed topics including agricultural societies, domestic and wild animals, insects, dairy, and education. Some of these evolved into the Dairy Bureau, the Massachusetts Agricultural Experiment Station, and the position of State Ornithologist.

The State Board of Agriculture (known also in its annual reports as the Board of Agriculture and the Massachusetts Board of Agriculture) was replaced successively by the State Dept. of Agriculture (St 1918, c 268) and the Dept. of Agriculture (St 1919, c 350, s 34) with an Advisory Board of Agriculture (s 35). St 1954, c 674, s 1 placed the department under the supervision and control of a new Board of Agriculture, replacing the advisory board (s 5). St 1969, c 704, s 3 placed the department within the Executive Office of Environmental Affairs. St 1974, c 806, s 1 (effective 1975) and St 1975, c 706, s 27 renamed the department and its supervisory board respectively the Dept. of Food and Agriculture and the Board of Food and Agriculture (also known as the State Board of Food and Agriculture). #### **Historical Note:**

St 1918, c 289 established in Massachusetts the Drainage Board to oversee the drainage of wetlands of the Commonwealth for agricultural, industrial, and public health purposes. It was to consist of a member of the State Dept. of Health and the State Board of Agriculture (renamed State Dept. of Agriculture that year). St 1922, c 349 redesignated members as being from the Dept. of Public Health and Dept. of Agriculture (per St 1919, c 350, ss 34, 96). St 1923, c 457 renamed the body the State Reclamation Board. St 1926, c 393 provided for a third member jointly designated by the two departments and governor and council, and placed the board in the Dept. of Agriculture. St 1975, c 706, ss 297-298 redesignated the first two members as from the Dept. of Environmental Quality Engineering and the Dept. of Food and Agriculture (in which the board now served). St 1977, c 641 designated the third member as from the Dept. of Environmental Management. St 1983, c 214 renamed the body as the State Reclamation and Mosquito Control Board (MGLA c 252, s 2).

#### **Historical Note:**

St 1860, c 192 authorized the governor of Massachusetts to appoint commissioners to deal with the pleuro-pneumonia epidemic among cattle of the Commonwealth, reporting to the State Board of Agriculture. St 1861, c 221 authorized a board of commissioners. St 1862, c 28 provided for the Board of Cattle Commissioners, who were reconstituted or discussed successively in St 1885, c 378; St 1894, c 491; and St 1899, c 408. St 1902, c 116 abolished the board and established the Cattle Bureau of the State Board of Agriculture. St 1912, c 608 abolished the bureau and created the Dept. of Animal Industry. St 1919, c 350, ss 39-40, 44 changed the department to the Division of Animal Industry in the Dept. of Conservation. St 1934, c 240 replaced the division with its Division of Livestock Disease Control in the Dept. of Agriculture (Dept. of Food and Agriculture per St 1975, c 706). St 1967, c 347 renamed the division as the Division of Animal Health. Its functions are currently described in MGLA c 129.

#### **Historical Note:**

Low prices during the Great Depression threatened the supply and distribution of milk, leading many states to create milk commissions or boards to establish minimum milk prices and otherwise regulate milk distribution. In Massachusetts, St 1934, c 376, the Milk Control Law, created the Milk Control Board within the Dept. of Agriculture, consisting of three gubernatorial employees to supervise and regulate the milk industry of the Commonwealth. Originally authorized for two years, the body was reauthorized by St 1936, c 300; St 1938, c 334; St 1939, c 413; and St 1941, c 418.

The Milk Control Law allowed the Board to designate and establish market zones for milk products; to supervise and regulate minimum prices, production, purchase, receipt, sale, payment, and distribution of milk; to require licensing of milk producers and distributors; and to control surplus milk products. The law authorized the Milk Board to establish, issue, enforce and revise orders, thus establishing and detailing regulations for the milk industry.

Such orders included the designation and redesignation of milk marketing areas, the fixing of milk prices paid to producers, and dealer licensing requirements. The Board also investigated violations of the law and revoked milk licenses.

St 1941, c 691, s 1 renewed the law, and established within the Dept. of Agriculture the Division of Milk Control. The division was under a director of milk control and under the control and supervision of a reconstituted Milk Control Board, chaired by the commissioner of agriculture and including two gubernatorial appointees. St 1945, c 497, ss 1-2 removed the commissioner from the board and substituted a third gubernatorial appointee. St 1953, c 604, s 1 replaced the Board with the Milk Control Commission, still within the Dept. of Agriculture. The three commission members were to represent milk dealers, milk producers, and the consumer.

Per St 1969, c 704, s 3, the division and commission were placed within the Executive Office of Consumer Affairs. St 1974, c 806, s 8 reestablished the commission and division within the Dept. of Food and Agriculture, then located within the newly established Executive Office of Environmental Affairs. --St 1983, c 691 terminated the division and transferred the functions of the Milk Control Commission and division into a newly created Bureau of Milk Marketing in the Division of Regulatory Services, under the commissioner of the Dept. of Food and Agriculture. Related functions are described in MGLA c 94A. (The bodies described above should not be confused with the Milk Regulation Board, 1932-1977, which was responsible for rules and regulations for inspection of dairy farms, grades of milk, and suitability of milk supplies from other states. #### **Historical Note:**

St.1891, c 412, s 7 established in Massachusetts a Dairy Bureau made up of three members of the State Board of Agriculture (State Dept. of Agriculture in 1918). The duty of the bureau was to investigate and inspect all dairy products and imitation dairy products bought and sold in Massachusetts, to enforce relevant manufacturing and transportation laws, and to investigate methods of commercial butter and cheese making. Resolves 1902, c 110 provided funds to the bureau for protection of purity of butter sold in Massachusetts. St. 1919, c 350, s 37 replaced the bureau with the Division of Dairying and Animal Husbandry (Dept. of Agriculture)

Massachusetts St 1902, c 495 provided for the State Board of Agriculture (State Dept. of Agriculture per St 1918, c 268) to appoint a State Nursery Inspector to visit at least once a year all nurseries or places where nursery stock was grown, sold, or offered for sale, with a certificate to be given if no dangerous insects or fungous pests be found. Further elaboration of the inspector's duties was made in Resolves 1911, c 103; St 1912, c 507; and St 1916, c 91. The inspector was replaced under the Dept. of Agriculture by the director of a

Division of Plant Pest Control (St 1919, c 350, s 37), then per St 1981, c 351, s 269 by the director of a Division of Regulatory Services.

On Feb. 6, 1894, Edward Howe Forbush was elected Ornithologist to the State Board of Agriculture in accordance with its by-laws. St 1908, c 245 established the office of State Ornithologist under the State Board of Agriculture (State Dept. of Agriculture per St 1918, c 268). The duty of that official was to investigate the distribution and food habits of local birds, to determine the relationships between the birds and outbreaks of insects and other animals, and to discover the best method of protecting fruits and crops from birds. Forbush was appointed to the post and served until 1928, from 1919 as director of the Division of Ornithology in the Dept. of Agriculture, per St 1919, c 350, s 37. --The division was abolished by St 1933, c 74. St 1934, c 173 reestablished the office of State Ornithologist in the Division of Fisheries and Game of the Dept. of Conservation.

Resolves 1949, c 28 established a special commission to be called: Market Authority, consisting of legislative and gubernatorial appointees, including the commissioner of agriculture ex officio, to investigate handling of essential fresh foods and to improve market facilities for such handling. St 1950, c 748 followed the commission's report to the legislature with establishment of the Massachusetts Marketing Authority with similar membership but including Boston officials as well, as a body politic and corporate, an instrumentality of the Commonwealth, to acquire land for a modern market project for named communities of metropolitan Boston, through the issuance of revenue bonds. St 1951, c 714 amended the preceding act to apply only to the city of Boston, which would acquire the marketing project when revenue bonds were paid. This being accomplished, the authority was abolished per St 1953, c 248. #### **Historical Note:**

In 1916 the Board of Harbor and Land Commissioners and the Directors of the Port of Boston were abolished and responsibility for the general care and supervision of the harbors, flats, tidewaters, including Boston Harbor, and the rivers and great ponds of Massachusetts was transferred to the Commission on Waterways and Public Lands (St 1916, c 288). With the reorganization of government agencies in 1919, however, the commission was abolished and its duties transferred to a Division of Waterways and Public Lands in the Dept. of Public Works (St 1919, c 350, ss 111-116)

In 1927 the division was absorbed along with the Division of Highways into the main body of the Dept. of Public Works (St 1927, c 297). However, it was reestablished as the Division of Waterways in 1938 (St 1938, c 407). Authority over Boston Harbor was transferred to the Port of Boston Authority in 1945 (St 1945, c 619)

Like its predecessor agencies, the division had as its primary responsibility to insure that the harbors and channels were fully navigable, and to otherwise improve, protect, and develop these areas.

To protect and maintain navigability, the division was authorized to license and oversee all construction in tidewaters and to license dredging or filling of harbors and flats within the line of riparian. In addition, it oversaw work beyond the line of riparian licensed by the legislature. In 1922 its licensing authority was extended to the Connecticut, Westfield, and Merrimack Rivers (St 1922, c 262). As part of the licensing function it oversaw license

plans and inspected work done under license. It also calculated displaced tidewater and determined method of compensation by payment of tidewater assessment fees or otherwise. It was directed to keep a record of all licenses granted and to insure that selectmen in towns where licensed work was to take place were notified.

To maintain navigability, the division was authorized to remove debris and obstructions, including wrecked, sunken, or abandoned vessels and to supervise the transportation and dumping of dredged materials.

To improve, develop, and protect the waterways, it was authorized to undertake construction and reconstruction projects; enter into contracts and agreements; initiate the taking of land for these projects; lease piers, wharves, and terminal facilities belonging to the Commonwealth for individual and commercial use; and remove obstructions and repair, reroute, and construct dams to protect against flooding in rivers and streams (St 1939, c 513)

Furthermore, the division could make recommendations for changing or establishing harbor lines.

To carry out these functions and activities, the division employed engineers to make surveys of harbors and rivers, to inspect licensed work and oversee contracts, and to make specifications and plans for contracts.

The division assumed the duties of the Division of Public Beaches in 1958 (St 1958, c 640) but in 1968 those duties were transferred to the Division of Forests and Parks in the Dept. of Natural Resources (St 1968, c 501)

Although the Dept. of Public Works itself was put under the Executive Office of Transportation and Construction by the reorganization act of 1969 (St 1969, c 704, c 19), the functions and organization of the Division of Waterways remained relatively constant until 1974, when the division was transferred from the Dept. of Public Works to the Dept. of Environmental Quality Engineering under the Executive Office of Environmental Affairs (St 1974, c 806, s 8). #### **Historical Note:**

The Board of Harbor and Land Commissioners, established in 1879, combined the duties and responsibilities of the Board of Harbor Commissioners and the Board of Land Commissioners (St 1879, c 263). Three commissioners were appointed by the governor and his council. They were required to keep a record of their activities and expenses and to submit an annual report in January of each year.

Responsible for the general care and supervision of the harbors and tidewaters, the board had as its primary function to insure that the channels were fully navigable and to otherwise protect, improve, and develop these areas.

To carry out this function, the board was authorized to license and oversee all plans and petitions relating to the building of bridges, wharves, piers, or dams over tidewaters, the filling of any flats, the driving of piles, or dredging in harbors. They determined and collected tidewater assessment fees for water displaced by licensed construction. They were also empowered to prevent and remove unauthorized structures or other encroachments. Engineers and assistants employed by the board made surveys, investigated license proposals, completed work, and reported back to the board.

In 1888 the board gained jurisdiction over the "great ponds" (i.e., those over ten acres) belonging to the Commonwealth (St 1888, c 318). These powers were broadened in 1904 when they were authorized to sell and convey or lease the islands in the great ponds with the approval of the governor and his council (St 1904, c 379).

In 1901, when the Topographical Survey Commission was abolished (St 1901, c 469), the board assumed its powers and took over work being done on the Town Boundary Survey, which was not completed until 1914.

In 1909 it was empowered to undertake projects for the improvement, development, maintenance, and protection of rivers, harbors, tidewaters, and shorelines (St 1909, c 481).

In 1911 its responsibilities in respect to Boston Harbor were transferred to the Directors of the Port of Boston, who were also charged with developing the Port of Boston (St 1911, c 748).

In 1916 both the Board of Harbor and Land Commissioners and the Directors of the Port of Boston were abolished and their powers and duties were assumed by the Commission on Waterways and Public Lands (St 1916, c 288).

The creation of the Commissioners on Public Lands under chapter 85 of the acts of 1861 consolidated the powers and duties of the Commissioners on the Back Bay and the office of land agent. However, after only two years responsibility was again divided, with the appointment of a commission of three to devise a system for the care and preservation of the Commonwealth harbors and the use of the flats (Resolves 1862, c 88). The commission reported on the condition of the flats between South Boston and the Channel and suggested plans for their improvement. Presumably acting on the report of this commission, in 1866 the legislature established a separate Board of Harbor Commissioners (St 1866, c 149).

With the creation of these other agencies, the powers and duties of the Commissioners on Public Lands were generally limited to oversight and development of Back Bay lands in Boston.

The Commissioners on Public Lands were abolished in 1877 and succeeded by the Board of Land Commissioners (St 1877, c 213).

#### **Historical Note:**

The Board of Harbor Commissioners was created by chapter 149 of the acts of 1866 to provide general care and supervision over all the harbors, tidewaters, and flats in Massachusetts except for Back Bay lands in Boston, which remained under the charge of the Commissioners on Public Lands (St 1861, c 89).

The board was comprised of five members appointed by the governor. They were required to keep account of their actual services and expenses and to submit an annual report in January of each year. They secured an advisory council consisting of U.S. engineers and

other U.S. officials. The advisory council was consulted for expert opinion and engaged to carry out coastal surveys. During this period the board cooperated with the federal government, which spent considerable sums of money on breakwaters and dredging in the smaller harbors of the Commonwealth.

The primary function of the board was to protect the harbors and channels in Massachusetts and to insure that they were fully navigable. They were empowered to supervise and oversee all plans and petitions licensed by the legislature that related to the building of bridges, wharves, piers, or dams over tidewaters, the filling of any flats, or the driving of piles. In addition, they were required to ascertain displaced tidewater and provide compensation by payment of assessment fees or by other means. In addition, they had the power to prevent and remove unauthorized structures or other encroachments; to inquire about land and water rights in South Boston; and to prescribe harbor lines, provided that a public hearing was held. To carry out these functions they were authorized to make surveys and employ engineers to investigate license proposals and completed work.

An act passed in 1869 further regulated tidewater construction by stipulating that all licenses granted by the legislature were revocable and would expire at the end of five years (St 1869, c 432). It further stipulated that all work done under the authority of license must meet with the approval of the Board of Harbor Commissioners.

In 1872, under chapter 236, the Board of Harbor Commissioners was for the first time empowered to grant licenses for work done within the line of riparian. All license requests beyond this line had to be approved by the governor and his council. Licenses granted by the board had to be signed by a majority of the commissioners and be recorded. The board also had to insure that selectmen of the town where licensed work was to take place were notified.

During the tenure of the Board of Harbor Commissioners, the South Boston flats were a priority. An 1866 resolve directed the board to report to the legislature on the filling of flats and the building of wharves in that area. To carry out the development there, it was authorized by various acts and resolves to acquire the property for the Commonwealth and to enter into contracts with persons and companies that were interested in developing it.

In 1879 the Board of Harbor Commissioners and the Board of Land Commissioners were abolished and their powers, duties, and responsibilities were transferred to the Board of Harbor and Land Commissioners (St 1879, c 263).

**Record Group Name: Directors of the Port of Boston** 

#### **Historical Note:**

In response to convictions held by leading businessmen in the Boston area that the time had come for more intensive development of the port facilities in and around Boston Harbor, chapter 748 of the acts of 1911 established the Directors of the Port of Boston as administrative officers in charge of the port. Boston Harbor was defined as the tidewaters and lands under water that lay between Point Allerton to the south and Point Shirley to the north.

All the powers, duties, and rights in respect to the lands, flats, and shores constituting Boston Harbor that were under the jurisdiction of the Board of Harbor and Land Commissioners were transferred to the Directors of the Port of Boston. Likewise, all maps, charts, plans, and documents pertaining to these lands were transferred. In addition, the

directors were charged with making the necessary plans for the comprehensive development of Boston Harbor. It was hoped that Boston would gain a commanding place among the leading ports of the world.

The directors were comprised of five members: three appointed by the governor and his council, one appointed by the mayor, and the chairman of the Board of Harbor and Land Commissioners. In 1914 legislation was passed decreasing the directors to three members appointed by the governor. The directors were required to keep account of their actual services and expenses and to submit an annual report the first of each year.

Powers, duties, and rights transferred from the Board of Harbor and Land Commissioners included the authority to (1) make surveys and employ engineers and assistants (2) prescribe harbor lines in any of the harbors as allowed by law (3) license and oversee all requests to build structures over tidewater including bridges, wharves, piers, or dams or to fill flats or drive piles below the high-water mark (4) ascertain volume of displaced tidewater caused by licensed work and determine method of compensation (5) collect fees from persons and companies leasing wharves, docks, or the like belonging to the Commonwealth (6) order legal suits on behalf of the Commonwealth relating to unauthorized works and vehicles within the tidewater.

In addition the directors were charged with developing the Port of Boston and authorized to undertake projects and enter into contracts. To do this, they studied and reported to the legislature on the present state and potential development of the port. They brought in consultants, corresponded with and entered into agreements with businessmen and steamship and railroad companies and undertook projects such as dredging shipping channels and developing docks and piers.

In addition to annual reports, the directors issued a supplemental report that laid down a policy for transportation development and a plan of construction in the Port of Boston (1914?) and a report on the South Boston dry dock contract.

In 1916 the Directors of the Port of Boston and the Board of Harbor and Land Commissioners were abolished and their powers were transferred to the Commission on Waterways and Public Lands (St 1916, c 288). However, their powers, duties, and functions were later resurrected in the Boston Port Authority (1929-1945), the Port of Boston Authority (1945-1953), the Port of Boston Commission (1953-1959), and most recently the Massachusetts Port Authority.

#### **Historical Note:**

The Topographical Survey Commission was established in 1884 (Resolves 1884, c 72). During its existence the commission had a mandate to carry out two projects: (1) a survey of the state and preparation of a contour topographical map (2) a town boundary survey (the determination by triangulation of boundary lines of cities and towns) (Resolves 1885, c 29).

The Topographical Survey Commission consisted of three members who were to arrange the details of the field survey work with the director of the U.S. Geological Survey. Work began in September 1884. By 1885, four survey field parties were at work under the direction of the U.S. Geological Survey and survey work was completed in 1887. Money was allocated by the state legislature for printing the topographical maps (Resolves 1890, c 57). The maps were printed from plates engraved by the U.S. Geological Survey and show only geological features; therefore the printed maps "omitted all detached country houses, as well as indications of the difference between forests and cleared fields, which are recorded on the original maps now in the possession of the Commissioners of the Commonwealth" (Atlas of Massachusetts. Boston: Topographical Survey Commission, 1890). A provision was made to distribute the atlases free to every public library and historical library in the state (Resolves 1891, c 95). Later free atlases were distributed to public schools in every town (Resolves 1894, c 83).

Soon after the topographical survey field work began, the commissioners realized that a definition of town boundaries would be a valuable addition to the topographical survey. At the instigation of the commissioners, legislation was passed (Resolves 1885, c 29) to provide for the town boundary work. C.H. Van Orden of the U.S. Coast and Geodetic Survey was put in charge of the field teams and work began on this second project in July 1885. Points of triangulation that were the reference points for the measurements were supplied by the U.S. Coast and Geodetic Survey. Triangulation points were also used from the Borden Survey done in Massachusetts in the 1830s. Correct determination of town boundaries was especially important at a time when cities and towns were expanding and supplying services such as water and sewers. According to the 1887 annual report of the Topographical Survey Commission, "the present condition of the records of town boundaries is simply scandalous." The commission also sponsored legislation to help preserve town boundary markers once they were established (Acts 1888, c 336).

Additional legislation was initiated to authorize the commission to resolve problems with the state boundaries with Rhode Island (Resolves 1897, c 88), New York (Resolves 1897, c 25), and Connecticut (Resolves 1898, c 39). Money was allocated for the duplication of atlases of towns showing the town boundary lines in 1897 (St 1897, c 69). Atlases were prepared for publication and published each year until the project was completed. As each atlas was published it was distributed free to towns, public libraries, and various other agencies (St 1900, c 360). The commission was abolished and its powers transferred to the Board of Harbor and Land Commissioners in 1901 (St 1901, c 469). Thus the field work of the survey and the computations and reductions of the field notes continued under that board until the work was completed in 1914.

#### **Historical Note:**

When the Division of Waterways was transferred from the Dept. of Environmental Quality Engineering (DEQE) to the Dept. of Environmental Management by St 1983, c 289, s 61; c 589, ss 15-16, DEQE retained those functions of the division relating to the licensing and permitting of structures and activities within the tidelands and waterways of the Commonwealth (St 1983, c 589, s 20). These were combined with the functions of DEQE's Division of Wetlands, which was replaced by the Division of Wetland Protection and Waterways Regulation. By 1988 it was known as the Division of Wetlands and Waterways Regulation, and by 1989 as the Division of Wetlands and Waterways, at which time DEQE was renamed Dept. of Environmental Protection (St 1989, c 240).

Currently the division administers the Waterways Regulation Program (implementing the Public Waterways Act, MGLA c 91), the Wetlands Protection Program (implementing the Wetlands Protection Act), the Wetlands Restriction Program (implementing the Coastal Wetlands Restriction Act and the Inland Wetlands Restriction Act) and the Wetlands/Waterways Enforcement Program.

**Record Group Name: Division of Water Supply** 

#### **Historical Note:**

St 1974, c 806, which established the Dept. of Environmental Quality Engineering within the Executive Office of Environmental Affairs as of July 1975, transferred to it the Bureau of Environmental Sanitation (actually known at that point as the Division of Environmental Health) from the Dept. of Public Health, including its powers and duties relating to water supply and water quality. Since then the department (renamed the Dept. of Environmental Protection in 1989) has been reorganized to assign these functions to the Division of Water Supply within the Bureau of Resource Protection.

The division develops and administers programs for protecting public drinking water supplies and systems, oversees maintaining programs to detect contaminants and pollutants in ground and surface water, and enforces state and federal regulations and guidelines for public drinking water. It provides technical assistance and educational programs to municipalities on long-term water planning and oversees protective programs for public and private wells that contribute to public water supplies. The division's functions are currently described in MGLA c 40 and c 111.

#### **Historical Note:**

St 1893, c 407, established the Metropolitan Park Commission, also known as the Board of Metropolitan Park Commissioners, to acquire, maintain, and make available to the public for exercise and recreation open space in Boston and surrounding communities to be known as the Metropolitan Parks District. The legislation set limits to be observed in acquiring property, but granted the commission authority to make and enforce regulations for its use.

The commission's responsibilities were extended to the construction and maintenance of roadways necessary to make parks accessible to the public. In this capacity, it could appraise and take land, set rules to govern its use, and appoint police for enforcement (St 1894, c 288), and cooperate with cities and towns to maintain roads adjacent to the parks (St 1896, c 465). Improvement of parks for recreational use included furnishing band concerts (St 1906, c 375) and establishing a zoo at the Middlesex Fells area (St 1907, c 449)

St 1893, c 475 had authorized the commission and the State Board of Health to investigate and improve sanitary conditions of the Charles River. St 1907, c 404 granted the commission joint authority with the Charles River Basin Commission to license boat clubs to construct boathouses, landings, and floats. On the abolition of the Charles River Basin Commission in 1910, its responsibilities were transferred to the Metropolitan Park Commission, including, as defined by St 1909, c 524, those for construction, maintenance, and improvement of dams and bridges on the river and for licensing boathouses, landings, and other structures. Authority to control pollution in the Charles River Basin, also included in the act, was strengthened by St 1914, c 531.

In 1919 the Metropolitan Park Commission was abolished along with the Metropolitan Water and Sewerage Board, and their combined functions were transferred to a new Metropolitan District Commission (St 1919, c 350, s 123)

#### **Historical Note:**

Massachusetts St 1866, c 238 appointed commissioners of fisheries in the Merrimack and Connecticut rivers to examine dams and establish and enforce fishways to allow free passage of fish. St 1867, c 344 expanded their powers to all rivers in the Commonwealth. St 1869, c 384, which detailed further regulations of waterways and fisheries, formally renamed the 1866 commissioners as the Commissioners on Inland Fisheries.

St 1886, c 276, s 7 extended the duties of the commissioners to additionally protect and preserve game (birds and animals) as well, now naming them the Board of Commissioners on Inland Fisheries and Game (in agency reports: Commissioners on Fisheries and Game). St 1902 c 178 gave the Board general authority to conduct investigations on fish and fisheries and game. With the establishment of the Dept. of Conservation in 1919, a Division of Fisheries and Game (St 1919, c 350, 43) was placed within it, including a director and staff to exercise the functions of the now superseded Board.

St 1929, c 372 established a marine fisheries section in the Division, under a State Supervisor of Marine Fisheries (replaced by 1939, c 491 with a separate Division of Marine Fisheries (q.v., EN5.05)) which was responsible for managing salt water fishing, including shell fishing and lobstering. The same 1939 act established a Division of Wildlife Research and Management. The State Ornithologist was added to the Division of Fisheries and Game per St 1934, c 173 (the Division of Ornithology was previously in the Dept. of Agriculture).

The Bureau of Law Enforcement was established within the Division of Fisheries and Game per St 1941, c 599. Per St 1948, c 651, a major reorganization of the Dept. of Conservation, the bureau was made a separate Division of Law Enforcement (s 1, i.e., MGL c 21, s 5) (q.v., EN5.02), and the Division of Wildlife Research and Management was converted into a bureau within the Division of Fisheries and Game (s 1, i.e., MGL c 21, s 7), now administered by a Board of Fisheries and Game (s 1, i.e., MGL c 21, s 2).

The Dept. of Conservation with its divisions became the Dept. of Natural Resources per St 1953, c 631. Per St 1974, c 806 the Dept. of Natural Resources (placed in the Executive Office of Environmental Affairs per St 1969, c 704, s 3, effective Apr. 30, 1971) was abolished, and its parts distributed among the agencies of an Executive Office of Environmental Affairs (as reorganized per the 1974 act), including a Dept. of Fisheries, Wildlife, and Recreational Vehicles, which contained the Division of Fisheries and Game. St 1975, c 706, s 56 renamed that unit the Division of Fisheries and Wildlife (administered by the renamed Board of Fisheries and Wildlife). St 1985, c 231, s 11, c 557 renamed the department the Dept. of Fisheries, Wildlife, and Environmental Law Enforcement, known since 2003 as the Dept. of Fish and Game. It still includes the Division of Fisheries and Wildlife, now also known as the Division of Inland Fisheries and Wildlife or MassWildlife. The division's functions are currently described in MGLA c 131, s 1A et seq.

The Division of Waterways (construction function only) was transferred to DEM from the Dept. of Environmental Quality Engineering (DEQE) per St

1983, c 289, s 61 and c 589, s 16. The Bureau of Solid Waste Disposal was deleted from DEM per St 1987, c 584, s 2A and its functions transferred to DEQE.

The department's stated function per MGLA c 21 is to exercise general care and oversight of the Commonwealth's natural resources and adjacent waters; to propose and carry out measures for their protection, conservation, control, use, increase, and development; and to carry on related investigations and research.

#### **Historical Note:**

The Water Resources Commission was established per Massachusetts St 1956, c 620 under the Dept. of Natural Resources, with a Division of Water Resources as the operating agency of the commission. A permanent division office and staff were instituted as of 1959. Among its duties were to rule on projects in wetlands areas, per the Flood Plains Protection ("Hatch") Act (St 1965, c 220), and the Wetlands Protection Act (St 1967, c 802). The 1977

annual report of the Dept. of Environmental Management (see below) summarized the mandate of the commission (and by extension the division) as responsibility for the study of the needs, supplies, and resources of the Commonwealth with respect to private and public use of water, water conservation, and flood damage prevention.

The Dept. of Natural Resources including its Water Resources Commission and Division of Water Resources was placed in the Executive Office of Environmental Affairs, created per St 1969, c 704 (effective Apr. 30, 1971). A reorganization of the executive office through St 1974, c 806 and St 1975, c 706 (both effective July 1975) discontinued the Dept. of Natural Resources, replacing it with, among others, the Dept. of Environmental Management (DEM), which included the Division of Water Resources, and the Dept. of Environmental Quality Engineering, which assumed from its predecessor regulatory powers over wetlands, and included the Water Resources Commission, to which the Division of Water Resources was still subject.

Per St 1983, c 589, the Water Resources Commission was placed directly into the Executive Office of Environmental Affairs, while the Division of Water Resources continued under the sole authority of DEM, assuming most of the commission's responsibilities. Nevertheless, St 1983, c 658, the Interbasin Transfer Act, designated the division to provide staff support for the commission's new responsibilities for reviewing and approving or denying all increases in interbasin transfer, such as diversion of water from one river basin system to another.

In 2003, DEM and the Metropolitan District Commission (MDC) merged to form the Dept. of Conservation and Recreation, under which the Division of Water Resources became the Office of Water Resources.

St 1905, c 381, s 2 mandated the gubernatorially appointed post of Superintendent for Suppressing the Gypsy and Brown Tail Moths. St 1909, c 263 abolished the post and added its responsibilities to those of the state forester, who pursuant to St 1919, c 350, c 42 became director of the Division of Forestry in the Dept. of Conservation. St 1937, c 415, s 2 extended the director's jurisdiction to the suppression of tent caterpillars. St 1948, c 660 placed the responsibility for regulating suppression of foliage-destroying insect pests (pests, per St 1949, c 761, s 1) declared to be public nuisances (MGLA c 132, s 11) with the post of Chief Moth Superintendent, reporting directly to the commissioner of conservation.

By 1953 the chief moth superintendent headed the Dept. of Conservation's Bureau of Insect Pest Control, which was mandated to continue in the Division of Forests and Parks in the new Dept. of Natural Resources and was made responsible for all tree spraying projects on state property (St 1953, c 631, s 1).

The head's title was changed to Chief Superintendent by St 1956, c 657, s 1. St 1985, c 765 (approved 1986) renamed the unit the Bureau of Shade Tree Management and Pest Control (since 1975, with its parent division, in the Dept. of Environmental Management) and extended its functions to shade tree management on state property and to providing technical, consulting, and financial assistance to municipalities in this as well as in suppression of pests. The agency's functions are currently described in MGLA c 21, s 4C; and c 132, ss 1A, 11-26G. (See also c 37.)

The Massachusetts Coastal Zone Management Program was designated by the Commonwealth of Massachusetts on Apr. 24, 1978 "to establish values and priorities for the use of coastal resources," having received federal approval under the Coastal Zone

Management Act of 1972, PL 92-583. It has been administered by an Office of Coastal Zone Management (cf. St 1979, c 610) within the Executive Office of Environmental Affairs, which was later legislatively authorized by St 1983, c 589, s 13 (there called: Coastal Zone Management Office) to "adopt, and from time to time amend rules, regulations, procedures, standards, guidelines, and policies which shall constitute the Massachusetts Coastal Zone Management Program...to secure for the inhabitants of the Commonwealth the objectives and benefits of the federal Coastal Zone Management Act." The director of the office also serves as an assistant secretary of the Executive Office of Environmental Protection.

While not a state regulatory agency, the office does review all activities directly affecting the coastal zone that require federal permits, to ensure that these are in compliance with approved state environmental management mandates such as provided in the Coastal Wetlands Restriction Act (St 1965, c 768). The office also reviews coastal-zone related projects requiring state or local permits; works with other state agencies to improve regulatory mechanisms to protect coastal resources and to set coastal management policies and priorities; provides technical assistance and facilitates financial assistance to coastal communities; and supports coastal-related scientific studies, mapping products, and citizen participation.

The Massachusetts Coastal Zone Management Plan under which the office operates includes regulatory policies (13) that call for protecting ecologically significant resource areas, and those of unique productivity; supporting national water quality goals; controlling construction and flood or erosion control permits, dredging construction and flood or erosion control permits, dredging projects, offshore sand and gravel mining, tideland industrial use, energy facilities, exploration and production of offshore oil and gas resources (with evaluation of alternative sources of energy and offshore mining), and subsurface waste discharge; protecting designated scenic rivers; and reviewing developments in or near historic districts or sites or public recreation sites.

Nonregulatory policies (14) include encouraging and assisting commercial fisheries; ensuring appropriate public works projects within the coastal flood plain; encouraging conservation or recreational use of hazard-prone areas; providing funding for flooding and erosion protection; encouraging development appropriate to community character and scenic resources; promoting public benefit from channel dredging; encouraging redevelopment of urban waterfronts; improving public access to and increasing capacity of coastal recreation facilities; assisting developers of private recreational facilities and sites that increase public access to the shoreline; expanding and acquiring public recreational areas; expanding energy conservation; ensuring that public transportation and wastewater projects serve existing developed areas; and encouraging revitalization of existing development centers in the coastal zone.

The office sponsors scientific studies, inventories, and mapping projects that include natural resources and waterfront facilities. Liaison with the public is facilitated by the Coastal Resources Advisory Board, instituted in 1978 and consisting of representatives of user groups appointed by the Executive Office of Environmental Protection, and citizen advisory committees.

## **Historical Note:**

The Water Resources Commission, chaired by the commissioner of natural resources, was established by St 1956, c 620 to supervise and control the Division of Water Resources in the Department of Natural Resources; and to coordinate the activities of federal, state, and other agencies in conservation, development, utilization, and disposal of water for preventing loss of life and damage to property by erosion, floodwater, and sediment in the watersheds of the Commonwealth. Per St 1966, c 685 it was also put in an advisory relationship to the Division of Water Pollution Control in the Department of Natural Resources (transferred to the Department of Environmental Quality Engineering per St 1974, c 806).

St 1975, c 706, which along with St 1974, c 806 replaced the Department of Natural Resources with the Department of Environmental Management in a new Executive Office of Environmental Affairs, put the Water Resources Commission, which still supervises the department's Division of Water Resources, under the Department of Environmental Quality Engineering (s 60). The division was put directly under the control of the Department of Environmental Management by St 1983, c 589, s 1, while by s 18 the commission was put directly under the Executive Office of Environmental Affairs, whose secretary chairs it, and was made responsible for development of water resources management policy and coordination of water resources planning and management functions within the executive office; it was also to promulgate rules and regulations relating to river basins of the Commonwealth, per St 1983, c 658.

Overall MWRA provides wholesale water and/or sewer services to Boston and sixty other communities located primarily in eastern Massachusetts; it also rehabilitates and reconstructs area water supply and sewage treatment facilities, to preserve public health and protect natural resources. Divisions include the following: Executive, Law, Waterworks, Sewerage, Program Management, Finance and Development, and Administrative Support. MWRA's functions are currently described in MGLA c 92 App s 1-1 et seq.

St 1980, c 508, s 8 (Hazardous Waste Facility Siting Act, codified as MGLA c 21D), established the Hazardous Waste Facility Site Safety Council (known also as the Massachusetts Hazardous Waste Facility Site Safety Council) as an independent Massachusetts state agency consisting of twenty-one members, including the secretary of environmental affairs and other state agency heads/designees and gubernatorial appointees representing municipal and industrial groups, relevant professions, and the public (s 4)

The council was responsible in conjunction with the Dept. of Environmental Management and the Dept. of Environmental Protection for overseeing siting of hazardous waste treatment facilities as provided by the Siting Act, including receiving notice of intent from the potential developer to construct or expand a treatment facility; establishing a list of acceptable facility sites; facilitating negotiations among developer, host community, and abutting communities; determining compensation paid by developer to abutting community; and declaring operative the siting agreement reached between developer and host community. The council was also responsible for management of a technical assistance grant program for local assessment committees commissioned by their communities to pursue such an agreement.

Facilities affected included those designed to store, recycle, treat, incinerate, or otherwise dispose of hazardous waste. Exempted from the siting process were manufacturers and other waste generators treating, recycling, or storing waste onsite without land treatment or waste disposal.

The council ceased to meet as a body after Mar. 1995; for FY 1995/1996 its functions were budgeted directly under the office of the secretary of environmental affairs (St 1995, c 38, s 2, item 2000-0100). Enabling legislation providing for the council's role in facility siting was repealed per St 1996, c 58, s 16.
