#### **Historical Note:**

The office of Secretary of the Commonwealth was established by the Constitution of 1780 as a position to be filled annually by joint ballot of the General Court. Amendment Article 17, ratified in 1855, made the office elective, while Amendment Article 82, ratified in 1964, fixed the term of office at four years.

The duties of the office were only vaguely defined by the Constitution. Instead it was left to later legislation to prescribe the custodial and record-keeping activities of the office and to define more closely the relationship of the secretary to the governor and council and to the General Court. In that respect the office retained the character of its predecessor offices. In 1628 a secretary was appointed by the governor and Company of Massachusetts Bay to keep the records of the company courts and to manage company accounts. Following the removal of charter and company to New England in 1630, a secretary was elected to keep the records and authenticate the orders of the General Court.

The secretary continued to be elected by the freemen of the colony and to be approved by the General Court until the introduction of a new province charter in 1691, when the power to appoint officers for the colony reverted to the Crown. In 1775, following the advice of the Continental Congress in Philadelphia, the General Court resumed control of the government in Massachusetts, declared the royal secretary absent and his office vacant, and appointed a secretary pro tempore for the colony. In 1776 the secretary of the colony automatically became state secretary until such time as the office was formally established under the Constitution.

As custodian of the records of the Commonwealth, the secretary inherited and continues to assume responsibility for the care and filing of those documents that form the legal foundation of the state. Today these include early charters, the state constitution and amendments, treaties and contracts concerning state properties, and engrossed acts and resolves of the General Court. In 1836 the secretary received custody of the Great Seal of the Commonwealth with corresponding powers of authentication, and in 1879 he assumed the responsibility for the use and disposition of all emblematic representations of the state.

Throughout the 19th century, efforts were made by the secretary's clerical staff better to manage his vast holdings. In 1821 and again in 1827, the secretary reported to the legislature on measures taken with regard to the arrangement and preservation of the public records and documents in his charge. In 1831 the secretary was required to select documents for retention in a vault especially constructed for that purpose on the northern front of the State House. Much departmental activity revolved around the copying of documents. This accelerated after 1830, when the Department of War requested evidential material from the secretary's office to substantiate Massachusetts pension claims.

From 1836 to 1846 a massive attempt was made to organize the records inherited from the colonial, provincial, and Revolutionary periods. The resulting compilation, known as the Massachusetts Archives, consisted of state papers from 1625 to 1799, arranged topically by volume in what one state secretary subsequently referred to as "chaotic disorder," and it remained the object of several indexing endeavors during subsequent years.

The legislative appointment in 1861 of a private secretary to the governor redefined, to an extent, the relationship of the secretary to the executive. Prior to 1861 responsibility for attending to and administering certain executive business fell to the secretary, who acted as ex officio clerk to the governor and council. The appointment of a private secretary relieved the secretary of the Commonwealth of those responsibilities, particularly any relating to executive correspondence.

As government activities and services expanded, the record-keeping duties of the office increased and were often accompanied by additional licensing and regulatory responsibilities. The secretary exercised his constitutional mandate of appointing deputies to act on his behalf to fulfill growing legal requirements. Particularly important was the statutory responsibility for registration of marriages and deaths in the state, a duty performed by the secretary's office from 1841 until 1976, when it was transferred to the Department of Public Health.

In 1919 the executive and administrative functions of the Commonwealth were reorganized into departments. Those functions previously exercised by the secretary serving directly under the governor or the governor and council were transferred to the new department of the secretary of the Commonwealth established under his immediate supervision and control.

In summary, the secretary of the Commonwealth (also known since the 1920s as the state secretary and more commonly called the secretary of state since 1979, when the designation Office of the Secretary of State came into use) is charged by the Constitution to keep the records of the Commonwealth. Statutory duties of the office include recording

executive proclamations; acting as a repository for statutory filings; issuing commissions to all gubernatorial and legislative appointees; filing certificates of commissioners in other states and foreign countries; administering the system of justices of the peace and notaries public; filing of rules and regulations of state agencies; registering all domestic, foreign, and nonprofit corporations; registering legislative agents (lobbyists); conducting the state census; supervising state elections; administering and enforcing the Massachusetts Uniform Securities Act, the Fair Information Practices Act, and the Freedom of Information Act; and preserving and managing all non-current records of the Commonwealth.

The secretary of the Commonwealth also publishes and/or distributes acts and resolves, constitutional amendments, public documents, the Massachusetts Register, the Code of Massachusetts, and the State Register of Historic Places; and serves as chair of the Archives Advisory Commission and of the Campaign and Political Finance Commission, as secretary of the State Ballot Law Commission, and as a member of the Massachusetts Historical Commission.

from them. These and other maps were bound between 1886 and 1891 into 69 volumes known as: Third series; oversize maps were stored loose on rollers and were known as: Numbered series. Maps previously bound into a five-volume set entitled: Ancient plans, grants were transferred to the new volumes. Maps acquired through 1900 were grouped in a new sequence by date, although continuing the previous numbering sequence; after 1900 maps were simply numbered as they were accessioned. Some maps acquired after 1891 were interleaved in the original 69 volumes, but most were left unbound. A bound volume showing the 1899 boundary line between Massachusetts and Rhode Island was marked as v. 70 at a later date, and in the 1950s several maps were put into two volumes marked v. 71 and 72. Third series and: Numbered series were combined in 1989 to form: Maps and plans. The practice of numbering maps accessioned as a whole or substantial part of another series was discontinued in 1986. But generally individual maps accessioned even with private provenance may still be numbered and shelved as part of this series.

#### **Historical Note:**

Pursuant to MGLA c 9, ss 2-2A, the Massachusetts Archives, under the direction of the state archivist on behalf of the state secretary, is responsible for securing, preserving, and managing for the public good, those noncurrent records of the Commonwealth determined to possess archival value by the Records Conservation Board. To meet this responsibility the Archives reviews and appraises records held by state agencies; acquires, weeds, arranges, describes, and processes records accepted by the Archives; conserves and preserves records held in the Archives; makes available for reference use records held in the Archives; administers various provisions of records law pertaining to records held in the Archives; administers the activities of the Archives Advisory Commission; and carries out surveys and other projects pursuant to its mission.

In addition the state archivist performs several ex officio responsibilities including representing the state secretary on the Records Conservation Board, the Archives Advisory Commission, the Board of Underwater Archaeological Resources, and the Board of Trustees of the State Library; serving as the state coordinator for the grants program of the National Historical Publications and Records Commission; and overseeing the records management program that operates under the authority of the supervisor of public records. While an Archives Division as such was not established within the secretary's office until 1897, the secretary's responsibility for managing the archives and records of the Commonwealth, grounded in the Constitution of 1780 (C 2, S 4, Art 2), dates back even further to colonial and Revolutionary War periods.

The Massachusetts Archives was first established as a separate unit within the secretary's office under St 1897, c 351, which designated the third clerk of the office as chief of the Archives Division. Further clarification was not made until St 1962, c 18, which mandated the chief of the Archives Division be a qualified archivist, to hold the office of Archivist of the Commonwealth. The division, now generally known as the Massachusetts Archives, has developed around that position.

The 1962 legislation also broadened the scope of records the Archives should encompass by specifying that the archivist was to be responsible for the noncurrent records of the Commonwealth. Up until this time, and even into the 1970s, collections in the Archives had consisted primarily of colonial and Revolutionary War records and the legislative collection.

In March of 1986 the Archives moved from the State House to a new facility at Columbia Point in Dorchester.

#### **Historical Note:**

St 1919, c 350, s 24 established a Supervisor of Public Records under the state secretary, succeeding the earlier Commissioner of Public Records in overseeing the care and custody of the records of the counties, cities, towns, and of state agencies in Massachusetts. The Supervisor and the Public Records Division provided services such as site records surveys, specification of standards for paper and ink, and oversight of records disposition activities.

Starting in the late 1970s, a records management team within the division (later known as the Records Management Unit) provided services such as appraising records and conducting records surveys, as well as developing and interpreting records retention and disposal schedules for county and municipal entities and state agencies. It also provided information and reports with guidance on best practices in areas such as records management, vault specifications and other record safekeeping, and electronic records. ### **Historical Note:**

The Census Division (or Division of the Census) was first mentioned as a unit within the state secretary's office in 1919, after St 1919, c 350, s 25 authorized the secretary of the Commonwealth to appoint a supervisor of the decennial census, responsible for collecting, compiling, and publishing census results. The agency name was not consistently used until the mid-1950s.

But long before 1919 the state secretary had been involved in census-taking activities. In 1837 the General Court authorized two censuses, in both cases stipulating the secretary's involvement: a population census to be used for allocating federal funds to towns in the wake of the dissolution of the United States Bank (St 1837, c 85); and a decennial census of "ratable polls" to be used for apportioning membership in the House of Representatives (St 1837, c 128) as required by the state constitution (Const Amend Art 12), ratified that same year. (Prior to 1837, censuses in Massachusetts were generally limited to the U.S. decennial censuses that commenced in 1790.) Each state census, with a few exceptions, was authorized by an enabling act that further defined its scope. Censuses were supervised by the state secretary, who was responsible for providing city and town officials with blank forms, for collecting returns, and for tabulating results. Enumeration itself was carried out by city and town officials.

Const Amend Art 13 changed the basis of representation from ratable polls to inhabitants and provided for state decennial censuses beginning in 1840. St 1855, c 439 mandated a decennial census at mid-decade, beginning in 1855, which had the effect of providing for a state census every five years. St 1857, c 60, however, abolished the end-of-decade census, taken in 1840 and 1850, which had coincided with the federal one. The scope of the census was changed to include an enumeration of legal voters to serve as the basis for determining representation, along with the census of inhabitants (Const Amend Arts 21-22). Decennial censuses of legal voters were used for determining legislative apportionment until 1970, when Const Amend Art 92 once again established a decennial census of inhabitants as the basis for representation.

In 1874 responsibility for the decennial census was transferred to the Bureau of Statistics of Labor (St 1874, c 386), which was put in charge of the 1875 and later enumerations of population, as well as of the decennial census of industries, which had been required of the

state secretary since 1865 (St 1865, c 146). (The agency was renamed the Bureau of Statistics in 1909.) Returns of census results, however, continued to be filed with the state secretary's office.

St 1919, c 350, s 25 returned sole responsibility for the decennial census to the state secretary and authorized him to appoint a supervisor of the decennial census who would be responsible for collecting, compiling, and publishing census information. (Responsibility for industrial statistics was given to the successor to the Bureau of Statistics, the Division of Statistics in the new Dept. of Labor and Industries (St 1919, c 350, s 69)). St 1920, c 157 redesignated the supervisor as state census director. St 1924, c 453 gave the secretary the authority to verify census information returned by the cities and towns and to make inspections of records if necessary.

Under constitutional and statutory provisions in effect through 1990, the state decennial census of inhabitants was conducted for the purpose of determining representative, senatorial, and councilor districts and as a basis for distributing state funds to cities and towns (Const Amend Art 101, as amended by Amend Art 109). In 1986 the state secretary for the first time exercised his statutory power by challenging returns from the City of Boston in the 1985 decennial census. The governor established a Decennial Census Commission to investigate. Among other things, the commission's report ((M-Ar)738X) questioned the need for a state decennial census and in 1987 and 1990 the General Court, meeting in successive constitutional conventions, voted to abolish the Census Division and its functions. This action was ratified by the electorate in Nov. 1990 (Const Amend Art 117).

Only returns from the censuses of 1855 ((M-Ar)213X) and 1865 ((M-Ar)214X), and summary returns from 1975 ((M-Ar)326X) were preserved. Census results for other years were recorded in printed reports issued by the state secretary (Reference Collection). **Record Group Name: Corporations Division** 

### **Historical Note:**

The Corporations Division, as it is currently known, operating within the Secretary of the Commonwealth's Office, is the central filing office for recording the registration and incorporation of businesses and other organizations in the Commonwealth of Massachusetts. Each type of organization files its own series of documents pursuant to the relevant laws as follows: corporations (MGLA c 156D (was B)); foreign (out of state) corporations (MGLA c 181); limited partnerships (MGLA c 109); trusts (MGLA c 182); professional organizations (MGLA c 156A); and charitable and other non-profit organizations (public charities) (MGLA c 180). The Corporations Division is also responsible for the recording of trade and service marks.

Early incorporations were authorized through charters granted through the state legislature, and recorded in legislation. Changes to this process began with St 1851, c 133, which established the rules and procedures allowing manufacturing and related businesses to incorporate as joint stock companies without legislative approval. The legislation required corporations to file their articles of organization and notice of any changes in capital stock with the state secretary, who was to publish and submit to the legislature an annual abstract of all filings. The secretary was to examine the articles of organization, verify their legality, and upon approval sign and seal a certificate of incorporation, which served as a charter. 1875, c 177 instructed corporations in the filing of amendments of their articles of organization with the secretary.

By St 1865, c 283, corporations were required to file with the Tax Commissioner an annual report detailing their holdings. St 1870 c 224, a codification of corporations law, included the filing of annual reports (known as certificates of conditions) with the secretary. The act also included the creation of a Commissioner of Corporations, a deputy Tax Commissioner appointed by the state treasurer to inspect incorporation filings. Articles of organization filings approved by the commissioner were then filed with the secretary, who issued, signed, and sealed the certificate of corporation, now on a standardized form. St 1919, c 350, ss 52-55 merged the Tax Commissioner and Commissioner of Corporations into the Dept. of Corporations and Taxation.

Filings of articles of organization kept by the state secretary were, from 1892 to 1905, and from 1924 on, according the secretary's annual report, the responsibility of its Corporation Division. St 1941, c 587 established a formal Corporation Division, to be headed by an attorney. St 1962, c 750 transferred many filing responsibilities from the Dept. of Corporations and Taxation to the secretary. The division then became responsible not only for keeping records and issuing certificates but for insuring that the registration and organization of corporations conformed to the general laws governing corporations in Massachusetts.

The incorporation of charitable and other non-profit organizations without the passage of legislative acts started with St 1857, c 56, which required the articles of association of charitable corporations to be filed in the registry of deeds in the county where the organization was located. Filing of articles of organization and the issue of certificates of charter by the state secretary for such organizations was established per St 1874, c 375. Similar procedures for the incorporation of churches were provided for by St 1887, c 404. Various acts later exempted many types of charitable and educational institutions from filing annual reports.

St 1901, c 405 required charitable organizations applying for incorporation to have their purposes and personnel investigated for possible illegal activity or unsuitable persons by the Board of State Charities (in 1919 the Dept. of Public Welfare), before they could be issued a certificate of incorporation by the secretary. St 1954, c 539, s 1 gave these investigatory and filing responsibilities to the newly-established Division of Public Charities in the Attorney General's Office.

Specific statutes regarding the filing of articles of organization and issue of certificates of charter for other types of businesses and professions include: insurance companies (St 1872, c 375), limited partnerships (St 1873, c 320), cooperative savings funds and loan associations (St 1877, c 224), and foreign corporations (St 1884, c 330). Added to the secretary's responsibilities per St 1893, c 443 was registration of labels, trademarks, or form of advertisement per St 1957, c 765, filings under the Uniform Commercial Code; and per St 1995, c 281, registration of limited liability companies and partnerships.

Resolves 1893, c 32 gave the secretary the funding to produce an index of corporation filings since 1780, arranged by type of business, and St 1959, c 327 directed the secretary to create an alphabetical index of the filings. Types of records filed with the division include applications; articles of organization and amendment; annual reports; change of officers and directors; bylaws; registrations; Dept. of Public Health, Dept. of Public Works, or Board of Higher Education approvals; revivals of dissolved corporations; and related correspondence.

# **Record Group Number: SC5**

**Record Group Name: Election Division** 

### **Historical Note:**

The Elections Division within the state secretary's office is responsible for coordinating all municipal, state, and federal elections within the Commonwealth. While there is no special

legislation that authorized the organization of these duties under a division, its existence is derived from provisions of MGLA c 9, s 2, which enable the state secretary to "employ such clerical assistance as he may deem necessary to carry out the laws relative to primaries and elections." These provisions first became law in 1911, when the secretary was authorized to employ "temporary" clerical assistance for elections (St 1911, c 550, s 19). In 1913 the word "temporary" was removed (St 1913, c 835, s 127). However, until 1948 only one permanent clerk was allowed for this purpose under the budget. In that year, three permanent positions were funded (St 1948, c 198, item 0504-01) and a supervisor of the Division of Elections named. Since the 1960s such personnel have commonly been designated as the Elections (or Election) Division.

Notwithstanding the relatively recent specific existence of an Elections Division, the state secretary's involvement in elections is grounded in the Massachusetts Constitution, which calls for town officials to transmit voting returns for statewide offices to the secretary's office (Const Pt 2, C 1, S 2 and Pt 2, C 2, SS 1-2)

Subsequent legislation expanded the secretary's constitutional role in elections by broadening the scope of elections in which that official could play a part to include those at the national and county levels (St 1788, c 49; St 1856, c 173) and by increasing the secretary's involvement in the conduct of elections. Responsibilities accumulated by the secretary over the years include the following: ensuring that returns are received in envelopes with their seals unbroken until their delivery to the governor or General Court (St 1806, c 26, augmented by St 1852, c 209, s 2, which authorized the secretary to refuse returns with broken seals); furnishing city and town clerks with self-sealing envelopes of uniform appearance to be used to make returns for all state and national elections (St 1851, c 226); furnishing city, town, and county officials with blanks for voting returns (St 1857, c 311); furnishing cities and towns with books to be used for registering voters (St 1877, c 208); providing cities and towns with ballot boxes (St 1884, c 299, s 10); preparing and transmitting to cities and town instructions for voters, including printed copies of proposed constitutional amendments and referendum questions (St 1888, c 436); and publishing election results in a public document, PD 43 (St 1890, c 423, s 118)

In sum, the state secretary's responsibilities as carried on by the Elections Division include verifying and printing nomination papers used by candidates; producing ballots; approving voting machines; registering and verifying Electoral College members and recording and printing proceedings of the Electoral College; providing information on running for elective office, absentee voting, voter registration, and general information for voters; and administering election procedures as required by law. #### **Historical Note:**

In 1890 the legislature mandated that any objections concerning nomination of state officials be brought before a board consisting of the secretary of the Commonwealth, the attorney general, and three other persons called ballot-law commissioners, who were appointed by the governor for one-year terms; they were to be from different political parties and to serve without pay (St 1890, c 436, s 5). Previously such questions had been handled by the secretary of the Commonwealth, the auditor, and the attorney general (St 1889, c 413, s 7). (The responsibility for decisions concerning city and town nominations was in the hands of each local board of registrars of voters, along with the city clerk and the city solicitor).

St 1892, c 406 designated the 1890 board as the Ballot Law Commission and authorized nominal payment to its members. It added the judicial powers to hold hearings, to summon and pay witnesses for testimony, and to require written reports to be presented as testimony at the hearings.

In 1896 membership on the commission (now referred to as the State Ballot Law Commission) was denied to any public official except those serving as justice of the peace or notary public, and to any employee or member of a committee of a political party. The size of the commission was reduced to three members, at least one of which should be from the political party receiving the largest number of votes for governor in the last election, and at least one from the party receiving the second highest number of votes. Appointments were for staggered three-year terms (St 1896, c 383, s 1). St 1898, c 548, s 154 added that any member who was a candidate for public office must resign from the commission.

The scope of decisions rendered by the commission was enlarged by St 1943, c 43 to include questions pertaining to certificates of nominations for any presidential or biennial state primary, biennial state election, or special state primary or election. Additionally, by St 1967, c 406, objections to initiative petitions filed under city charters, as forwarded by city councils or school committees, could be heard by the commission.

In order to ensure an accurate, legal, and confidential vote, the state secretary, treasurer, and auditor approved ballot boxes provided to each city and town holding an election (St 1890, c 423, s 84). In 1903 a separate body for this purpose was established as the State Board of Voting Machine Examiners (St 1903, c 368). It was required to examine voting apparatus and report to the secretary its approval or disapproval. Following the ratification in 1911 of the constitutional amendment authorizing the use of voting machines at all elections (Const Amend Art 38), the members of the State Ballot Law Commission were to serve as the State Board of Voting Examiners (St 1912, c 641). They were required to examine all voting machines, ballot boxes, and counting apparatus and to submit their approval together with written descriptions, drawings, specifications, and photographs. If machines failed to conform to state requirements, the board was responsible for notifying the secretary, who in turn notified the towns to replace the machines (St 1912, c 641, s 1). These responsibilities were transferred from the commission to the state secretary in 1977 (St 1977, c 930).

The State Ballot Law Commission was restructured by St 1977, c 927, with its membership being increased to five persons appointed by the governor. One member, designated as chairman for a one-year term, is to be a retired justice of the state court system; other members serve two-year terms, and no more than three members may be of the same political party. This act designates the state secretary as secretary of the commission and requires that the proceedings of hearings and all decisions be kept as a public record.

The primary functions of the commission, as outlined by this statute, are to investigate the legality, validity, completeness, and accuracy of all nomination papers and actions required by law to give candidates access to a state ballot or to place initiative or referendum questions there. The commission is responsible for ballot access questions concerning the constitutional qualifications of any candidate, certificates of nominations, the filing of nomination papers under a false name, or fraudulent or forged initiative petitions, and continues to be responsible for holding hearings and rendering decisions in these matters. Any authority over state public policy ballot questions or over municipal candidates or ballot questions was denied the commission by St 1980, c 134, s 8. The commission is administratively within the Elections Division of the state secretary's office, but not subject to the secretary's jurisdiction.

#### **Historical Note:**

Pursuant to MGLA c 9, ss 26-28, the Massachusetts Historical Commission (MHC) administers historic preservation programs and funds for the purpose of protecting and making available for public appreciation the Commonwealth's historic and archaeological resources.

The commission was established by St 1963, c 697 within the state secretary's office to advise on matters relating to historic assets of the Commonwealth and to assist in compiling and maintaining an inventory of them. Initially the MHC's attention was focused towards historic properties and sites. The enabling act empowered the commission to examine certain sites and structures; make recommendations concerning historical significance; and certify eligible sites as historic landmarks. In addition the legislation enabled cities and towns to establish historical commissions to work in conjunction with the MHC in recommending sites for historic landmark status.

St 1971, c 517, s 2 further authorized the commission to develop historical surveys and plans in accordance with requirements of the federal Historic Preservation Act (16 USC ss 470-470N) and to be the sole agency of the Commonwealth responsible for the act's administration.

In the 1970s the commission's activities came to encompass archaeological as well as historic sites. By St 1971, c 643 the legislature authorized the establishment of the position of State Archaeologist to be appointed within the commission by its chair. The duties and responsibilities of this position were delineated in St 1973, c 1155 to include responsibility for preservation and protection of archeological resources of the Commonwealth by compiling and maintaining an inventory of historic and archeological sites and specimens, conducting surveys and field investigations, recommending sites for status as archeological land marks, and issuing permits for exploration and field investigations. St 1973, c 989 established a Board of Underwater Archaelogical Resources (within the Dept. of Public Works; later in the Dept. of Environmental Quality Engineering, now Dept. of Environmental Protection) and designated the MHC as one of the agencies to be represented on it.

St 1982 c 152, s 4 provided for the commission to establish and maintain a State Register of Historic Places, to include all districts, sites, buildings, objects determined eligible for listing or listed in the National Register of Historic Places, all local historic districts established pursuant to MGLA c 40C, all landmarks designated under local ordinance or bylaw, all structures and sites subject to a preservation easement approved or held by the commission pursuant to MGLA c 184, s 32, and all historic or archeological landmarks certified pursuant to MGLA c 9, s 27.

St 1988, c 254, s 7 mandated that prior to undertaking, licensing, or funding public or private construction projects, state agencies must first notify the commission, which is to determine any direct or indirect effects the project might have on any property listed in the State Register of Historic Places and then to discuss ways to eliminate, minimize, or mitigate adverse ones.

#### **Historical Note:**

The Massachusetts Regulations Division within the Office of the Secretary of State (also known as the Rules and Regulations Division) carries out the secretary's constitutional and statutory record-keeping functions in relation to laws passed by the General Court and rules and regulations issued by state agencies. The division was formally established in 1978 to meet the need created by St 1976, c 459 to publish a Massachusetts register and a Code of Massachusetts Regulations. However, as early as 1975 there was an office stamp

for such a division, although a director is not listed in the Manual of the General Court until 1981-1982.

Notwithstanding the current existence of a separate division, the state secretary's responsibility for regulations can be traced to St 1917, c 307, which stipulated that any rules and regulations promulgated by departments, commissioners, boards, or officials that contained provisions for penalties would not take effect until filed with the state secretary's office. St 1951, c 556 extended the provision by requiring that all rules and regulations, regardless of a provision for penalty, be filed with the secretary's office to ensure a central depository for all effective regulations. During this time the filings were carried out under the direct supervision of the secretary. From 1971 through 1975, they appear to have been delegated to the Public Records Division of the secretary's office, as evidenced by office stamps that were used when regulations were received.

Once the division accepts filings of rules and regulations from state agencies, it publishes them in the Code of Massachusetts Regulations, and, along with notices of pending adoption of regulations or of hearings thereon, and other documents, including executive orders, in the Massachusetts register, in accordance with MGLA c 30A, ss l-6.

From 1978 the Massachusetts Regulations Division assumed the state secretary's responsibilities for printing, publishing, and distributing legislation passed in current sessions of the General Court, in accordance with MGLA c 5, ss 2-3. The Legislative Engrossing Division of the General Court had already taken over the secretary's function of preparing parchment bills for final passage, per St 1971, c 34, but the Massachusetts Regulations Division maintains and binds these engrossed copies of acts and resolves; it also maintains original bill packets for such acts and resolves, and publishes the State register of historical places in conjunction with the Massachusetts Historical Commission. **Record Group Name: Public Records Division** 

#### **Historical Note:**

Civil procedures and record-keeping have been fundamental ingredients of public administration in Massachusetts from the outset. Throughout the colonial and early national periods, local government officers were regarded as the primary keepers of public records.

The first action leading to the establishment of systematic regulation of records occurred in 1884 when the General Court resolved to authorize the appointment of a person by the governor and council to report "upon the condition of the public records of the parishes, towns and counties of the Commonwealth." Carroll D. Wright was selected to do this study, leading to a published report in 1889. Wright became the first commissioner of public records.

In 1892, under chapter 33 of the acts of that year, the commissioner became a permanent post to be filled by the governor for a three-year term. The commissioner was mandated to see that the records of the counties, cities, towns, churches, and parishes of Massachusetts were put into the condition and custody contemplated by the several laws dealing with the subject.

Legislation continued to refine and extend the authority of the commissioner. St 1898, c 67 authorized the commissioner to spend money to achieve the preservation of local public records. The Revised Laws of 1902 refined and added to the powers of the commissioner on several points. St 1913, c 485 extended the authority of the commissioner to the records of the Commonwealth (i.e., state agencies).

In 1919 a major reorganization of the government of Massachusetts occurred, the blueprint for which was chapter 350 of the acts of that year. The public records function was subject to that change. Section 24 of chapter 350 abolished the post of Commissioner of Public Records and transferred all its powers, duties, and obligations to the secretary of the Commonwealth. The secretary, in turn, was authorized to appoint, with the approval of the governor and council, a suitable person to hold a post designated Supervisor of Public Records. The supervisor was to exercise all of the functions held earlier by the commissioner of public records.

The Public Records Division (known until 1952 as the Division of Public Records) grew up around the post of supervisor. Functions such as site surveys, specification of standards for paper and ink, and assisting with records disposition activities called for increased staff. By the late 1970s, a records management team was conducting surveys and providing reports on records management across Massachusetts. While serving the mandated responsibility of the supervisor of public records, the team was aligned with the Archives Division in 1982 more closely to coordinate archival and records management business at all jurisdictional levels.

The 1970s also found the division assuming other public records responsibilities. During this time, public access to records (freedom of information) was becoming an increasingly discussed issue. In 1973 the General Court greatly expanded the provisions for access to public records. Three years later, St 1976, c 438 established the supervisor of public records as the state agent responsible for determining whether access to public records was appropriate when conflict arose after a request was made. In response to this, an intervener section of the Public Records Division evolved.

Access to recorded information also came to involve fees charged by records custodians for copies of records. In 1977 the attorney general issued an opinion that asserted that the supervisor of public records was authorized to establish fee schedules to govern the furnishing of copies of public records. Thus an additional function was incorporated into the division.

Responsibilities for administering commissions and regulating legislative agents (lobbyists), which have come to rest with the division, are discussed in the histories of the Commissions Section and the Lobbyist Section respectively.

#### **Historical Note:**

Regulation of the activities of legislative agents in the Commonwealth began in 1890. St 1890, c 456 (amended by St 1891, c 223) divided these regulating duties between the sergeant-at-arms of the General Court and the secretary of the Commonwealth. Under the law's provisions, the responsibility for registering legislative agents was the duty of the sergeant-at-arms. He was required to prepare and keep legislative docket books containing the names, residences, occupations, and dates of employment and termination of agents, as well as the names and business addresses of their employers. Later legislation (St 1895, c 410; St 1896, c 342) required agents to file with the sergeant-at-arms written authority signed by their employers.

St 1890, c 456, s 6 placed the responsibility for keeping the records of expenses incurred by the employers of legislative agents under the jurisdiction of the secretary of the Commonwealth. Under St 1973, c 981, the agents themselves were also required to file such statements with the secretary. The same act removed the responsibility for registering legislative agents from the jurisdiction of the sergeant-at-arms, and placed it under the state secretary, thereby uniting all aspects of regulation of lobbyists under one office. There the activity has been delegated to the Public Records Division, and in the 1980s more specifically to the division's Lobbyist Section.

#### **Historical Note:**

The state secretary is constitutionally mandated to attest to all commissions issued in the name of the Commonwealth of Massachusetts and signed by the governor (Const Pt 2, C 6, Art 4). To administer this function, a Commissions Division emerged as a distinct part of the secretary's office by 1961; after 1976 the unit became the Commissions Section of the Public Records Division.

The Commissions Section swears in appointed state officials, notaries, and justices of the peace; certifies the signature of public officials; authorizes nonresident clergy to perform marriages in the Commonwealth; maintains a list of the local option statutes accepted by each municipality; and records the name of all public appointees including members of local, regional, and state public boards and authorities.

#### **Historical Note:**

The Archives Advisory Commission (AAC) was established in the Office of the Secretary of the Commonwealth of Massachusetts per St 1973, c 711 (MGLA c 9, s 2A). The commission is mandated to advise the state secretary on archival matters and, with the Archivist of the Commonwealth, to act as Massachusetts's central advisory body for historical records planning and to serve as a coordinating body to facilitate cooperation and communication among historical records repositories and information agencies within the state, both public and private.

The National Historical Publications and Records Commission (NHPRC), the grant-making affiliate of the National Archives and Records Administration, in 1976 required each state to establish a state historical records advisory board (SHRAB) in order to receive federal grants under its records program. The Massachusetts AAC served as the model for the National Archives when it established the SHRABs, and in Massachusetts, it serves as the Massachusetts Historical Records Advisory Board (MHRAB). The MHRAB was organized under the provisions of 36 CFR pt 1206 to serve as the state-level review body for proposals submitted to the NHPRC grant program.

**Record Group Name: Records Conservation Board** 

#### **Historical Note:**

The Records Conservation Board is responsible for determining, in consultation with state agencies, the final disposition of all records, including all books, papers, maps, photographs, other recorded information, and "public records" as defined in MGLA c 4, s 7, regardless of physical form or characteristics, created or received by any agency not in the legislative or judicial branch (MGLA c 30, s 42).

The board replaced and expanded upon the functions of a similar board established by St 1920, c 174, without official name, but eventually known as the Obsolete Records

Commission, which had the authority to sell or destroy any duplicate, obsolete, or worthless records, books, or documents held in the State Library or in state agencies, in consultation with the agencies and in accordance with statutory provisions. Members included the supervisor of administration, the supervisor of buildings, and an assistant attorney general. Under subsequent legislation the state librarian, the chairman of the Commission on Administration and Finance, and the supervisor of public records were made members of the board (St 1923, c 362, s 47; St 1936, c 359; St 1951, c 397).

When the Records Conservation Board was established in 1962 (St 1962, c 427), the state archivist was made a member and designated as ex officio secretary of the board to insure that no records would be destroyed without his knowledge. The state auditor was also made a member. Since 1964 membership includes the state comptroller, state librarian, attorney general, commissioner of administration, supervisor of public records, and state archivist, or their designees (St 1964, c 131).

While the board has retained the power to sell or destroy public records, the 1962 legislation expanded the responsibilities held by its predecessor. It gave the board the power to require all departments of the Commonwealth to report what records they hold, and the responsibility for setting standards for the management and preservation of these records, and for establishing schedules for the destruction or transfer to the Archives of records no longer needed for current business. The boards's authority did not and still does not extend to judicial or legislative records.

#### **Historical Note:**

The museum section of the Massachusetts Archives began as the State House Museum, serving to display charters and other foundation documents of the province, colony, state, and commonwealth of Massachusetts. In 1983 it was established as a separate division within the office of the state secretary, known as the Commonwealth Museum. Although, per MGLA c 9, s 2, the state secretary shall operate and supervise the archives museum and shall utilize those records of historic value for exhibition and education purposes, followed by the provision that the archivist of the commonwealth shall supervise the operation of the archives museum, in fact the museum has had its own director from 1984.

With the move of the state archives in 1986 from the State House to a new facility at Columbia Point, the museum display initially consisted of a permanent exhibit on

Massachusetts history, but was then followed by a series of traveling exhibits. In 2009, a refurbished space opened, housing a new permanent exhibition, based on copies of Archives holdings, but also including a treasures gallery containing the state's actual copies of the Declaration of Independence and the Bill of Rights, and the first leaves of the 1629 and 1691 charters and the 1780 state constitution, along with Paul Revere's copper engraving of the Boston Massacre.

#### **Historical Note:**

The first guided tours of the Massachusetts State House were provided for by St 1968, c 714, which placed responsibility for this function under the Archivist of the Commonwealth under the direction of the state secretary, then, per St 1976, c 147, directly under the state secretary, with such personnel as he might deem necessary (MGLA c 9, s 2). The resulting State House Tours and Government Education Division is commonly designated simply as the State House Tours Division or Tours Division. The division maintains a program designed to encourage public interest in the State House and in historical memorabilia of

the Commonwealth. The division organizes and provides for guides through the state's capitol building including an architectural and historical tour and a legislative process tour, and produces a number of programs and brochures explaining the history of the State House, state government, and the passage of legislation. The division provides materials and information for school groups, journalists, historians, and travel professionals. It also manages the operation of the State House Gift Cart.

# **Record Group Name: Commission on Interstate Cooperation**

#### **Historical Note:**

The Commission on Interstate Cooperation was established in 1937 (St 1937, c 404) as a successor to the Commission on Interstate Compacts Affecting Labor and Industries, which the same legislation abolished. That commission had been established in 1933 (Resolves 1933, c 44) to investigate the establishment of a uniform wage standard in Massachusetts and other northeastern states during the Depression, with the state secretary being asked to communicate with the secretaries of other states on this issue. The successor Commission on Interstate Cooperation was also placed under the state secretary, but was in no way subject to his control.

The commission had fifteen members, nine of whom were members of the General Court, three from the Senate and six from the House of Representatives. There was to be one member each from the Uniform State Law Commission and the State Planning Board, and four members were to be appointed by the governor. In 1953 the director of the Division

of Planning of the Department of Commerce was substituted for the member of the State Planning Board (St 1953, c 409).

The primary function of the commission was to represent the state as a member of the Council of State Government. Particular attention was to be paid to fair and reasonable standards for labor in regard to the minimum wage, conditions of employment, and the employment of women and minors. The commission was also to appoint a member to the Commission on Minimum Wage. This provision was repealed in 1943 (St 1943, c 255). The commission was allowed to establish committees or advisory boards to aid its work. Persons not on the commission could serve on the committees to facilitate their work.

The Commission on Interstate Cooperation worked in the field of taxation and promoted cooperation with the federal government and other states. In 1938 the commission had standing committees on labor and industry, taxation, crime prevention, and highway safety and motor vehicle problems. By 1940 additional committees on conservation, sanitation, and interstate waters had been established. The commission studied and investigated problems such as the migration of industry in 1938 and marine fisheries in 1940, and promoted state participation in various interstate compacts. In 1953 committees also existed on water resources, social welfare, agriculture and conservation, civil defense, crime control, taxation and fiscal policy, transportation, and highway safety. These committees continued in existence through the 1960s. The commission was also a member of the Atlantic States Marine Fishery Commission, the Northeastern Forest Fire Protection Compact, and the Council of State Government Board of Managers.

The Commission on Interstate Cooperation ceased as of July 1988, when the legislature voted not to fund it further. It was felt that the commission duplicated many functions that were routinely carried out by other state agencies.
