To the honoured generall court of the Massachusets Collonies the humble representation of the John of Concord both freemen and others.

Forafmuch as we understand, that there have been complaints made unto his Majestie, concerning divisions amongst us, and dissatisfaction about the prefent Government of this Colonie; we whose names are underwritten doe hearty testific carnest define of the Continuance thereoff and of all the sibertys, and privileders apportanting therunto, which are contained in the Charter grounded by the famis, and ting harles the first gainst Memoris; under the encouragement, and security of which Charter, we or our fathers ventured over the Ocean, into this wild energy the engreat hazzards, charges, and difficulties; And seeing our rightfull Soveraigns hath privileders you with power of force of arms to define this place and people (we having encourament from the konducto Council; cannot all acknowledge it a mirror of good that you for minds the good and preferention of this place, and people, according to oath we doe declare that we are reader to afsist both with persons and estates, that for by the arm Domaine your in all Humble observance
