About the Corporation Division

The Corporation Division of Secretary of the Commonwealth William Francis Galvin's Office is the repository for certain records of approximately two hundred and fifteen thousand business and nonprofit corporations and over two hundred thousand limited liability entities organized or registered to do business in the Commonwealth. In addition, the Corporation Division maintains records for limited partnerships and business trusts. Limited liability companies, limited liability partnerships, service marks, trademarks, and uniform commercial code (UCC) filings are also made with the Corporation Division.

Corporate Documents are filed between the hours of 8:45 a.m. to 4:00 p.m., Monday through Friday.

Corporate Certificates are issued between the hours of 8:45 a.m. to 4:00 p.m., Monday through Friday.

UCC Documents are filed between the hours of 8:45 a.m. to 5:00 p.m., Monday through Friday.

Many of these entity records and filings may be viewed by the public as images in the corporate database. Those records and filings received prior to 2001 were microfilmed or fiched and are available for public inspection from 8:45 a.m. to 5:00 p.m., Monday through Friday in the Public Room. Online filings and public search is available at **www.sec.state.ma.us/cor**.


