V. Any additional notes on perceived causes of discrepancies:

This audit resulted in tallies that are almost identical to our election night tally. The audit also revealed slight discrepancies between the hand count and election night results in several contests; those discrepancies were also largely mirrored by differences between the counts of blank ballots and Write-in votes in the subject precinct. These variances may be the result of differences between the optical scanners and human beings in determining if a voter made a selection or not in particular contests.
