**NOTICE OF PUBLIC HEARING**

Pursuant to the authority of M.G.L. c. 118E and in accordance with M.G.L. c. 30A, the Executive Office of Health and Human Services (EOHHS) will hold a remote public hearing on Tuesday, January 31, 2023, at 11:00 a.m. relative to the adoption of:

**101 CMR 362.00: Rates for Community Support Program Services**

The proposed regulation, 101 CMR 362.00, establishes the payment rates used by governmental units to eligible providers of community support program (CSP) services.

The proposed regulation will: (1) allow eligible providers to bill governmental units for the CSP services codes established in 101 CMR 362.00; and (2) establish rates for four models of CSP: CSP, CSP for Homeless Individuals (CSP-HI), CSP for Individuals with Justice Involvement (CSP-JI), and CSP Tenancy Preservation Program (CSP-TPP). The proposed rates were developed using a cost modeling methodology, which constructed rates using provider cost and utilization data, supplemented with applicable market data and other relevant data.

EOHHS is proposing this new regulation to ensure that payment rates are consistent with efficiency, economy, and quality of care, to ensure that payments are reasonable and adequate to meet the costs that must be incurred by efficiently and economically operated, and to satisfy the requirements of M.G.L. 118E, sections 13C and 13D. It is estimated that annual aggregate MassHealth expenditure will increase by approximately \$8.87 million for community support program services. There is no fiscal impact on cities and towns.

The proposed regulation contains rates effective for dates of service on or after April 1, 2023.
